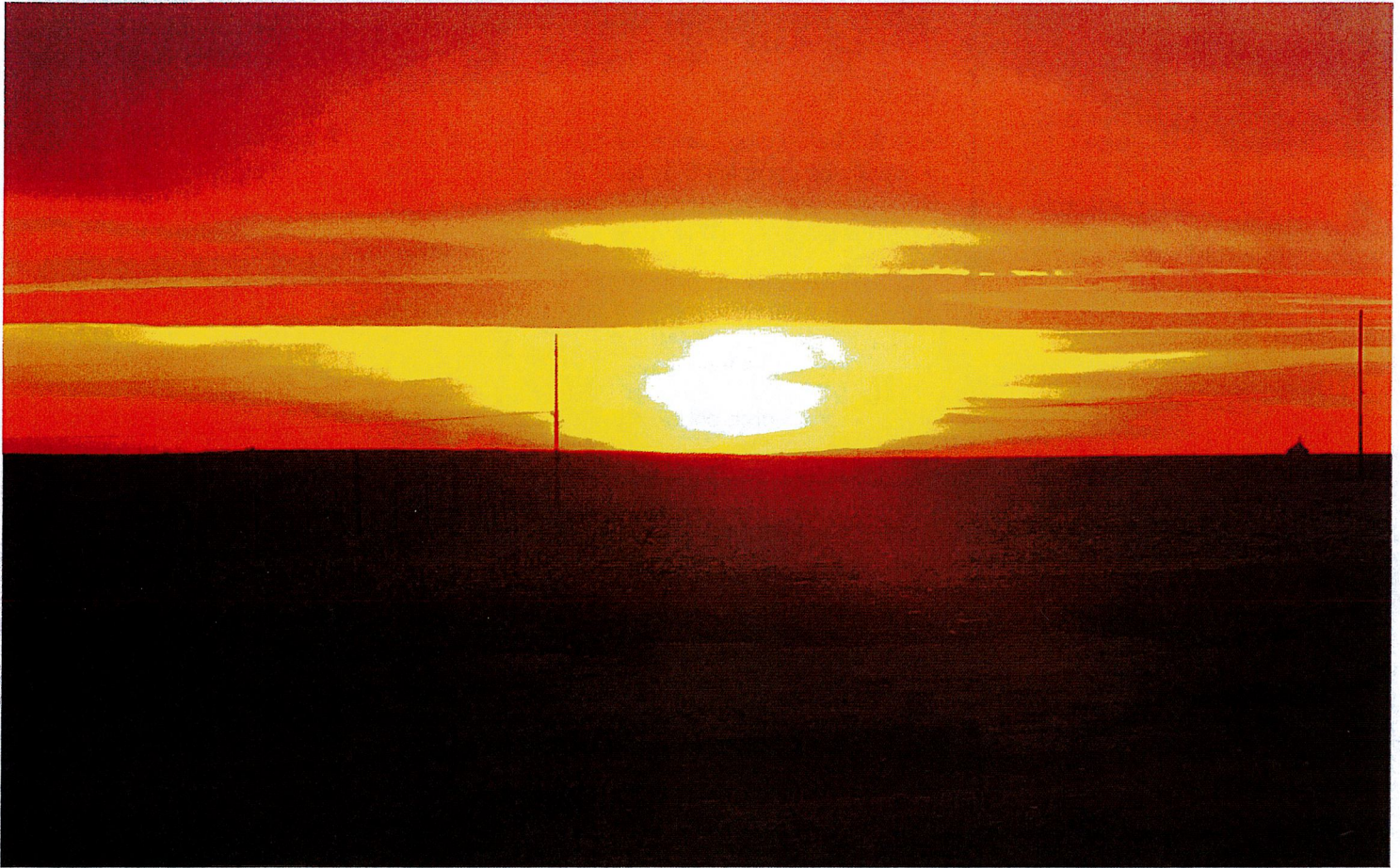

WATER METER UPGRADE

In the coming months, the City will be conducting a Water Meter Upgrade project. The City is contracting **Ferguson Waterworks** to complete the installation.

A few weeks before the project begins, you will receive a letter from the City containing additional information on how to schedule your appointment.

There is no cost for the upgrade, but you are required to have your water meter replaced.

To install the new radio upgrade:

Ferguson Waterworks will need access to the meter inside your home or business.

The water meter area should be clear and accessible.

An adult 18 years old or older must be present at the time of installation.

Ferguson Waterworks was selected based on their experience as a meter installation contractor. All installers will have identification, wear uniforms, travel in marked vehicles and have completed background checks.

The City of Springville and Ferguson Waterworks thank you in advance for your cooperation in making this a successful program.

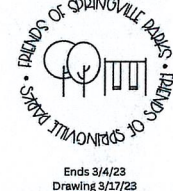

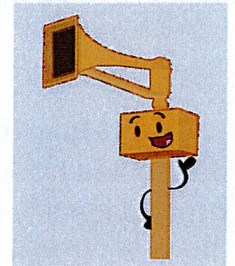

Our mission is to bring awareness and financial assistance to multiple military causes including Gold Star Families, veteran suicide, PTSD, homelessness, and much more.

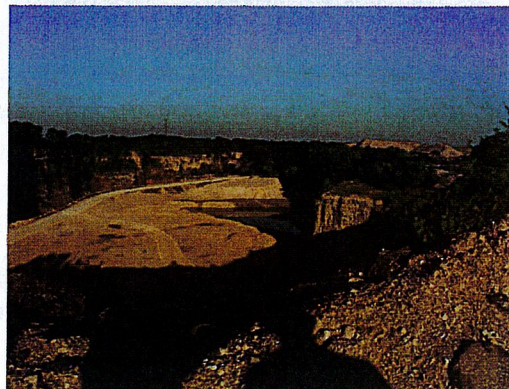

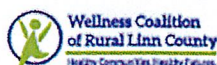

A STROLL THROUGH THE HIS

Music was focus of Fred Taylor's high school years

When Fred Taylor was a student at Springville High School from 1935 to 1939, academics were important to him, but music – both vocal and instrumental – was where he really shone. He even sang in shop class to entertain his fellow students!

He sang tenor in various vocal groups, and also performed solos. In concert band, pep band, and small groups, he played brass instruments, mainly trombone and baritone horn. Fred and a classmate, Margaret Wells (daughter of the local dentist) also sang duets at local weddings and funerals. No canned music in the 1930s!

One of Fred's favorite teachers was Roy Schwab, band director. Another was Miss Geneva Waters, who taught English. During part of Fred's high school years, Bertha Nelson (later Koppenhaver) taught vocal music, biology and home economics. She was required to resign when she married; that was how things were then. Fred went to school under two superintendents, Clyde Hoorneman and William Johnston. Lewis Thoma was principal.



Fred's high school music education was supplemented by private voice lessons in Cedar Rapids. His instructor was a woman of Italian heritage; he doesn't recall her name. (That was over 84 years ago!) Either his father drove him to Cedar Rapids, or he drove the family car. High school students usually didn't have their own cars in the 1930s Depression years.

Fred is especially proud that the Springville band advanced to national contest in spring 1939, his senior year. During high school, he earned many I ratings in contests, both in small groups and as a vocal or instrumental soloist. In his senior year, he sang a tenor solo and received the only I rating, plus special commendation from the contest judge, who noted that he "displayed unusual talent."

Fred inherited his musical talent from his father, Fred Glen Taylor, who sang bass in Springville's male quartet. Other members were dentist Claude Wells, John Yocom, and Dr. William Pirie, a veterinarian.

Although he was tall and could have gone out for basketball, Fred – who went by Freddie all through school – did not take part in high school sports. "Music occupied all the time I wasn't in class," he explained.

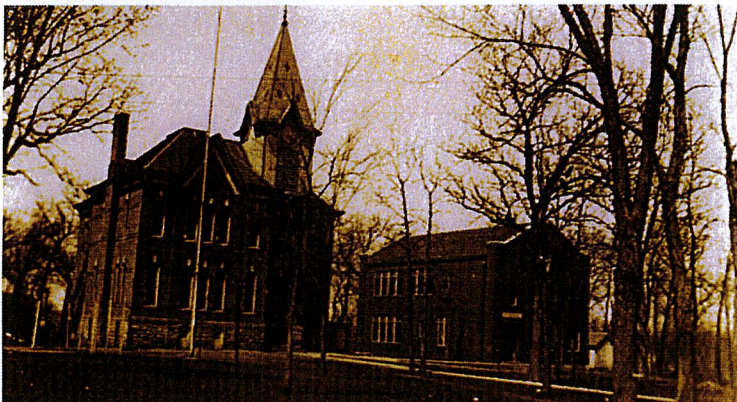
While busy with music and studying, Fred did make time for other things. His father had a small dairy at the family home, 309 North Ave. Each morning before school, Fred and his brother Bob rode the running boards of a pickup truck driven by their father, delivering milk. They also milked the small herd of cows.

Fred had a social life, too. The first Springville girl he dated was Arleta Smith, daughter of the Methodist minister. He also went out with Jean Marie Burroughs (later Feuerbach, then Branch). For movie dates, he borrowed his father's car and drove to the Niles Theater in Anamosa. Tickets were 10 cents each. On "guys' nights out," Fred and other boys hitchhiked to Anamosa for movies. He recalls one time that

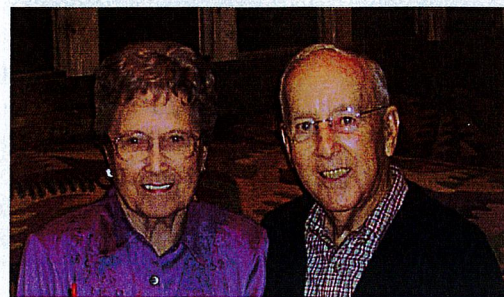
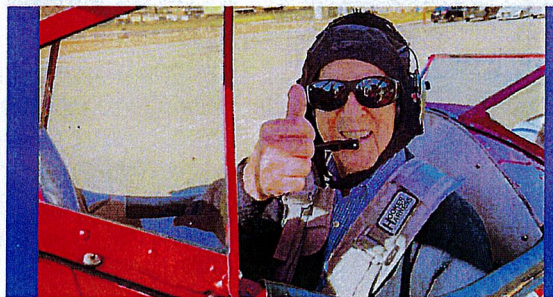

they couldn’t get a ride home, and walked all the way back to Springville, about 10 miles by moonlight.

Fred’s last year in high school had the usual spring activities. The senior class trip was a one-day outing to McGregor, Iowa. The junior-senior banquet was held at a Cedar Rapids hotel. Commencement took place May 25, 1939, at the Springville Methodist Church. Diplomas were awarded to 31 young adults. Then Fred “Freddie” Taylor enrolled at Cornell College.

Receiving college diploma – 80 years later

A 101-year-old Springville native, Fred Taylor, will have a starring role in Cornell College’s commencement May 14 this year. Eighty years after he was scheduled to graduate, he will fly from California to walk across the stage in Mount Vernon, wearing cap and gown, to receive his long delayed Cornell diploma.

Fred wasn’t able to be at commencement in 1943 because he was serving in World War II as a pilot in the Army Air Corps. His Reserve unit was activated in February of his senior year at Cornell. He received credit for his unfinished courses, which was standard procedure for college men in that situation.

Two of Fred’s brothers, Maynard and Robert, also served their country in World War II. All three Taylors’ names are on the front of Springville’s American Legion building.

After basic training at Jefferson Barracks, Mo. (nicknamed “Pneumonia Gulch” because the men had to sleep in tents

during winter), Fred was sent to Pineville, Ark.; Independence, Kan.; and Eagle Pass, Texas, for increasing levels of flight training. Then he was stationed in Colorado Springs, Colo., where he married Peggy Newberg Sept. 30, 1944. They had met as students at Cornell.

In spring 1945, Fred was sent to Italy. He was discharged from the Army Air Corps in early fall of 1945. Back in the United States, he earned his M. A. degree in music at Drake University in Des Moines.

Fred’s first music teaching job was in Bayard, a town in Guthrie County, Iowa. In 1959, he made a major change in location, moving to La Mesa, Calif. (near San Diego) with Peggy and their daughter Linda. He and Linda, a retired university professor, are still living in the house that Fred and Peggy bought in 1959. After more than 75 years of marriage, Peggy died in March 2020.

CORNELL’S COMMENCEMENT will begin at 10 a.m. May 14 on the lawn in front of McLennan College Hall. (Built in 1857, it was already a seasoned building when Fred Taylor attended Cornell from fall 1939 to February 1943.) No tickets are required; there will be ample seating. Audience members are requested to be seated by 9:45 a.m.

THE TAYLOR FAMILY has several long-lived members. Fred’s father lived to 95 and his mother to 93. Fred’s sister Marguerite Upham, 11 ½ years his senior, lived to 104. His paternal grandfather, Joseph Washington Taylor, died in 1949 at age 100. When Fred turned 100 on Nov. 13, 2021, a card he received congratulated him on becoming a “centurion.” (It’s **centenarian**, but the thought counts!)

SPRINGVILLE WATER QUALITY REPORT - 2022

Introduction: In compliance with the Safe Drinking Water Act Amendments, The City of Springville's water system is providing its customers with the annual water quality report. This report explains where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. **For more information about your drinking water, please contact Todd Wyman, Public Works Director, at 319-854-6428.**

Does my drinking water meet EPA standards? Yes, our water meets all of EPA's standards. We sample for over 80 contaminants that may be in drinking water. As you will see in the table contained in this report, we found all contaminants always met the EPA guidelines.

What is the source of my water? Your water comes from two municipal wells. One well is 473 feet and the other is 390 feet into an underground source of water called the Silurian Dolomite Formation. These wells are located at the water tower and at the east end of the football field. The town owns the land where the wells are located and restricts any activity that could pollute them to ensure the safety of our water. The State has completed a source water protection evaluation. The Springville water supply obtains its water from the Silurian aquifer. The Silurian aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying materials allow contaminants to move through the aquifer fairly quickly. The Springville wells will be most susceptible to activities such as leaking underground storage tanks, pesticide manufacturers, and air release permitted sites. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources and is available from the City of Springville at the city clerk's office at 304 Broadway, 7:30 a.m. to noon and 12:30 p.m. to 4:00 p.m., M-F, 319-854-6428.

How can I get involved? Our City Council meets on the first and third Mondays of each month at 6:00 p.m. in City Hall at 304 Broadway, Springville. Please feel free to participate in these meetings.

Is our water system meeting other rules that govern our operations? In order to ensure that tap water is safe to drink, EPA prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. The State and EPA require us to test our water on a regular basis to ensure its safety.

Do I need to take special precautions? Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Why are there contaminants in my water? Drinking water, including bottled water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Springville is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.

Information on lead in drinking water, testing methods and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agriculture livestock operations and wildlife.
- *Inorganic contaminants*, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, stormwater runoff, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- *Radioactive contaminants*, which can be naturally occurring or be the result of oil and gas production and mining activities.

Health Affects of Lead in Your Drinking Water: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and you children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Springville is responsible for providing high quality drinking water but cannot control the variety of materials used plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>.

Other Information: Our water system is currently working with the community to increase awareness of proper waste disposal practices, to further protect the source of our drinking water. We are also working with other agencies and local watershed groups to educate the community on ways to keep the water safe.

Water Quality Data Table: The water quality data table on the next page lists all the contaminants that were detected during monitoring for the 2022 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Most of the data presented in this table is from testing done between January 2018 to December 31, 2022. The State requires us to monitor for contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Definitions of the terms used in the table and explanations of the abbreviations are as follows:

Definitions:

- **MRDLG:** The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- **MCLG:** Maximum Contaminant Level Goal, or the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- **MRDL:** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants. MRDLs are set for chloramines, chlorine, chlorine dioxide.
- **MCL:** Maximum Contaminant Level, or the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- **AL:** Action Level, or the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

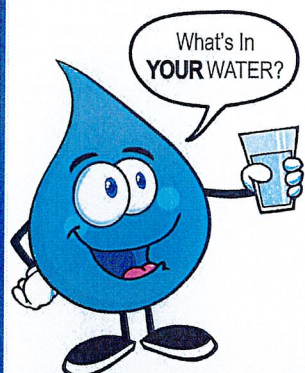
