
Mayor's Minutes

A STROLL THROUGH THE HIS

Tamar Brown's granddaughter had a baby in 1861

On June 11, 1861, Martha Sammons gave birth to a son she named Roland. Martha, 22 and unmarried, lived with her parents and seven younger siblings on a Linn Township farm south of Springville. Two older sisters were married.

Martha's baby was a great-grandson of Tamar Brown, widow of Revolutionary War veteran Nathan Brown. Ira Sammons, Martha's father, was Tamar's son by her second marriage. (Nathan Brown was her third husband.)

Tamar lived in Brown Township, about a mile southwest of Springville. She might have met her new greatgrandson, as she lived until March 1867.

In 1864, the entire Sammons family – including Martha and little Roland, 3 – moved to California. Mary Sammons, 8, Martha's youngest sister, died in route. Her grave site is unknown.

In 1875, Martha married Charles H. Bixby in the Salinas Valley. She was 36, he 38. Roland turned 14 that year. He soon had two half siblings – Alta Bixby, born in 1876, and George Oliver Bixby, 1878.

Charles and Martha Bixby moved to a ranch south of Monterey. In 1905, they retired to 517 Madison St., Monterey. Martha, widowed in 1915, died Nov. 18, 1928. She and Charles are buried in Monterey City Cemetery.

Roland predeceased his mother. He died July 20, 1918, and was interred in Garden of Memories, Salinas, Calif. He was 57 and apparently unmarried.

His full name was Roland Sammons Butler, suggesting that his father was a Butler. In 1861, Joseph S. Butler, 40, was living in Springville with his wife and two sons. His involvement seems unlikely.

William Butler from Vermont, 27 in the 1860 census, lived in Linn Township – closer to the Sammonses. But after 158 years, the paternity of Martha's first son remains a mystery.

Ira Sammons was born in November 1805, youngest of Tamar Lyon Lane Sammons' four children from her first two marriages. He was about 18 months old when his mother married Nathan Brown in Onondaga County, N. Y.

The family later relocated to Erie County, N. Y. There in 1842, Ira married Elvira Bailey. They moved to Linn County, Iowa, about 1839, and to California in 1864.

Between 1833 and 1856, Ira and Elvira had ten children. Their names were Caroline, Almira, Martha, Orrin, Lavisa, George A., Horace F., Delana "Lana," Thomas B., and Mary. Ira died in April 1886, Elvira in 1895. Their graves are in Napa, Calif.

Arthur A. Storrs located, a long way from Iowa

Arthur Aurey Storrs could run from Iowa – but he couldn't hide from DNA technology almost a century youngest N later. Thanks to efforts of his second family, especially wa one, 30 granddaughter Nancy K. Thompson Price, his formerly hidden story has emerged.

Genealogy

Arthur's father, Andrew Dana Storrs, was born east of Springville in 1857. Andrew earned a law degree at the University of Iowa and practiced law in Des Moines. There he married Elizabeth Blanche Knapp, and their son Arthur was born in 1882. Soon after, the parents moved to Hawarden in far western Iowa. Five more children were born.

On May 7, 1908, Arthur married Iva Leota Patrick Arff. Their sixth child, Grace, died soon after birth Feb. 20, 1920. Just 18 days later, Iva succumbed to pneumonia. Arthur was left with Gilbert and Virgil (Iva's sons by her first marriage), Aurey Arthur, Jesse, Margaret, Martha, and Richard.

Iva was interred at Ute in Monona County, where the family had lived until moving to Arion, Crawford County, about 1916. Arthur's double loss apparently overwhelmed him, and he vanished. His children never saw or heard from him again.

New name, new life: Arthur Storrs fled to Pascagoula, Miss., on the Gulf Coast. He changed his name to Art Dale and invented a new set of parents (David and Margarette Kelly Dale) and a new birth-place (Philipsburg, a small town in western Montana).

Arthur/Art remarried Aug. 15, 1924. Mary Celestine Dismuke, 19 years his junior, already had a son, Lionel. Between 1925 and 1934 Donald, Bernice, Elsie, Eugene, Aileen, and Helen where born.

On March 18, 1938, Arthur/Art left his second family when cirrhosis of the liver took his life at 56. He was

buried in Machpelah Cemetery, Pascagoula. His youngest Mississippi child was about 4; his eldest lowa one, 30. Mary Celestine, his widow, lived until May 1990.

Genealogy sleuth: Thanks to Nancy K. Thompson Price of Pascagoula, who emailed the Springville City

Clerk about her discovery. (Online, she had found the March 2019 Springville News article about the grandfather she knew as Art Dale.)

Also, posthumous thanks to Nancy's aunt, Aileen Dale Newman. In 2016, she provided the crucial DNA sample





that linked Art Dale to the Storrs family. Mrs. Newman, daughter of Arthur Storrs, died in 2017.

Nancy has written a detailed report covering her intensive quest to discover Art Dale's true identity.

ARTHUR A. STORRS' paternal grandparents, Andrew and Elizabeth Gamberton Storrs, came to Linn County, lowa in 1849 from Cortland County, N.Y. They farmed east of Springville for about 30 years. Elizabeth was a descendant of William Bradford, a Mayflower passenger who was governor of Plymouth Colony and author of "A History of Plimouth Plantation".

The Springville City Council met in regular session in the Springville Council Chambers on November 4, 2019. Mayor Shebetka called the meeting to order at 6:00 p.m. Council members present: Brad Merritt, Lyle Andersen, Jeff Grimley, and Mareta Ralston. Dennis Thies was absent. City Staff present: Public Works Director Todd Wyman, and City Clerk/Treasurer Dee Wagaman. Guests present: Ryan Hosch of MSA, Karl Markley, Pat Hoyt Sr., Larry and Kerrigan Riley, and Karla Blakely.

Andersen made a motion to approve the agenda, second from Merritt. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of October 21, 2019 minutes and Approval of bills second from Grimley. All ayes. Motion carried.

Mayor Shebetka invited citizens with input to speak. There being no comments from citizens, Mayor Shebetka moved to business.

Mayor Shebetka opened the public hearing to consider adding Chapter 53 pertaining to Noise and Noise Limits to the Springville Code of Ordinances. No comments in favor or against the proposed addition. Merritt made a motion to close the public hearing at 6:01 p.m., second from Ralston. All ayes. Motion carried. Andersen made a motion to approve the first reading of Ordinance 18-2019, and ordinance to add Chapter 53 to the Springville Code of Ordinances, second from Grimley. RCV: AYES: Merritt, Grimley, Andersen, and Ralston. ABSENT: Thies. Motion carried.

Ralston presented Resolution 132-2019, a resolution to approve the updated drug & alcohol policy, second from Andersen. RCV: AYES: Merritt, Grimley, Andersen, and Ralston. ABSENT: Thies. RESOLUTION 132-2019 adopted.

Hoyt addressed the council about a nuisance letter he received requesting a barricade be removed from City property. He explained the history of why it was there. Council has received complaints so have asked that it be removed from City property. Hoyt will move the barricade to his property.

Wyman asked for direction on purchasing of annual Christmas tree for Butler Park. A couple of years the City has received donations, Hoyt will get clerk name of a property owner who is cutting down a large tree. Wyman directed to try to stay local.

Hosch presented the final update for the Sanitary Sewer project. The DNR still needs to do their inspection and MSA will come out to do final inspection before warranty is up. Just need to do final draw request for engineer costs. Andersen made a motion to approve SRF draw request #11 for \$6,150.75, second from Grimley. All ayes. Motion carried.

Hosch also presented to council a Springville Trail Feasibility Study that MSA had done in 2015.

Sheriff Tindal presented the Linn County Sheriff's report. There were 14 calls for service between 10/21/19-11/4/19.

Wyman presented public works report.

Wagaman presented clerk/treasurer report.

Mayor reminded everyone to go vote.

The next regular council meeting will be November 18, 2019 at 6:00 p.m. at City Hall.

There being no further discussion, Andersen moved to adjourn at 6:33 p.m., second from Ralston. All ayes. Motion carried.

Andersen made a motion to approve the agenda, second from Thies. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of November 4, 2019 minutes and Approval of bills second from Ralston. All ayes. Motion carried.

Mayor Shebetka invited citizens with input to speak. There being no comments from citizens, Mayor Shebetka moved to business.

Mr. Blackford addressed the council regarding the notice of violation he received. He asked for an extension due to the weather and his work schedule. Andersen made a motion to allow an extension to February 1, 2020 for the violation at 407 1st Ave, second from Thies. All ayes. Motion carried.

Sheriff Tindal presented the Linn County Sheriff's report. There were 15 calls for service between 11/4/19-11/18/19.

Andersen presented 2nd reading of Ordinance 18-2019, an ordinance to add noise and noise limits to the Springville Code of Ordinances, second from Grimley. RCV: AYES: Thies, Grimley, Andersen, and Ralston. ABSENT: Merritt.

Ralston presented Resolution 133-2019, a resolution to close the City streets for the winter parade, second from Andersen. RCV: AYES: Thies, Grimley, Andersen, and Ralston. ABSENT: Merritt. RESOLUTION 133-2019 adopted.

Andersen made a motion to purchase and place two concrete barriers at the south end of Water Street, second by Thies. All ayes. Motion carried.
