## February is American Heart Month



**Heart disease is the leading cause of death for both men and women, but heart disease is preventable and controllable.**

The five major symptoms of a heart attack are: Pain or discomfort in the jaw, neck, or back, sweating, nausea, feeling weak, light-headed, or faint, chest pain or discomfort, pain or discomfort in arms or shoulder, shortness of breath. If you think that you or someone you know is having a heart attack, call 9-1-1 immediately.

### Did You Know?

You **should not lie down** while waiting for the EMT. You should keep aspirin by your bedside. Bayer makes crystal aspirin to dissolve under the tongue. ***They work much faster than the tablets.*** **Note:** There may be NO pain in the chest during a heart attack. However, if it occurs, the chest pain may wake you up from your deep sleep. The majority of people (about 60%) who had a heart attack during their sleep did not wake up. **If that happens, immediately dissolve two aspirins in your mouth and swallow them with a bit of water.**

Afterwards: **CALL 911** - say "heart attack!" - say that you have taken 2 aspirins- phone a neighbor or a family member who lives very close by- take a seat on a chair or sofa near the front door, and wait for their arrival and...**DO NOT LIE DOWN!** A Cardiologist has stated that, if each person, after reading this information alerts ten other people, probably one life can be saved! *I have already shared the information - What about you?* **Do forward this message; it may save lives!**

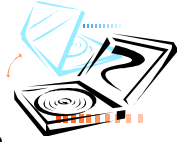

### WHEN SNOW FALLS PLEASE REMEMBER THIS!!



When conditions of 4" of snow are predicted, imminent, or exist on the traffic surface of the street, please **Do not park** your vehicles along any streets. This allows the snowplows to get through early in the morning.

- ◆ If you must park on the street, please move the vehicles as soon as possible.
- ◆ Do not blow or shovel snow into the street. Pile it in your yard. The snow you place in the street requires another pass from the snowplow and it will just end up in your own driveway when they go by.
- ◆ **Sidewalk Ordinance #136.03: REMOVAL OF SNOW, ICE & ACCUMULATIONS.** It is the responsibility of the abutting property owners to remove snow, ice, and accumulations promptly from sidewalks. If a property owner does not remove snow, ice, or accumulations within a reasonable time, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax.



### Official says 99.9% of Iowa ash trees will succumb to EAB, discusses financial impact

Amid the continued spread of the Emerald Ash Borer (EAB) throughout Iowa, a state forestry specialist says all ash trees in the state will be dead within 20 years – and he's "done the math" for the costs associated with removing the millions of ash trees found in Iowa. None of the news is good.

## Historical Feature

### McShane Recalls 1936-37 Adventure

On April 21, 1936, a small Harley-Davidson motorcycle left Whittier, Iowa, for Idaho. It carried Ivan "Ike" Hoge and Aubrey McShane, both 19. They traveled 1,500 miles to join Ike's cousin, Ray Hobson, whose family had moved to Coeur d'Alene the previous summer. The two adventurers tied their cardboard suitcases to the back fender. "That didn't work very well, so when we got to Blair, Neb., we shipped the suitcases to Idaho. It cost me \$1.20," Aub said. He recorded his expenses, which now seem incredibly low: lodging (five nights), \$2.20 *total*; meals, \$2.45; half the gasoline, \$7.79; and half the oil, \$4.68.

"Hobson had told us we could get jobs on fire watch towers," said Aub. "That wasn't so. For a week, I helped his dad deliver buttermilk to three towns up in the mountains. I applied for jobs at a copper mine and a lumber yard, but wasn't hired." Next he cut and burned brush for 23 days on a mountain ranch near Coeur d'Alene. He and Ike slept in an unheated garage, but the meals were good. "That ranch had 500 chickens and an acre of asparagus," he recalled. Aub and Ray then worked 11 months at the Waikiki Dairy north of Spokane, Wash. Co-workers made it clear they considered Iowa "the sticks." But Aub bragged after discovering that the dairy's modern washing and bottling machine was made by Cherry Burrell in Cedar Rapids! In April 1937, Aub and Ray learned of jobs at the Grand Coulee Dam construction site on the Columbia River. Aub thought workers had to be 22; he was 20. "So I went to the Social Security office in Spokane, said I was 22, and got another card," he related. "Then I learned kids as young as 16 were hired!" Aub and Ray rented a two-room cabin about 2 miles from their work site. One room had a wood-burning stove, a single electric ceiling bulb, and a hotplate. Ray owned a car, but after a week or two, he found work at an ice cream shop. Then Aub hitchhiked to his job. For six months, he worked 5 p.m. to midnight, five days a week. At first, he was on the "rock gang." After blasting was done, he picked up rocks and put them in a huge metal box that had cables attached, for removal from the site. The pay was 50 cents an hour. Later he had a job spreading grout on sections of poured concrete for 65 cents an hour. On Oct. 2, 1937, President Franklin D. Roosevelt visited the dam in an open yellow Lincoln touring car. Aub went to FDR's speech in Mason City, Wash., and used Ray's camera to photograph the President. Soon after that, Aub quit his job and took a Greyhound bus back to Springville. As he got off the bus at Briner's store Oct. 16, by sheer chance his cousin, Homer McShane, was there to greet him.

**POSTSCRIPT:** Ivan "Ike" Hoge worked for an asphalt company in Coeur d'Alene until August 1936, then rode his motorcycle back to Whittier. He died July 7, 2011, age 94. Raymond "Ray" Hobson settled in Amity, Ore. He died Oct. 24, 2010, at 93. Aubrey McShane, 97, is a retired farmer living north of Springville. The book "Grand Coulee Dam" by Ray Bottenberg (Images of America series, Arcadia Publishing, 2008) has two photos showing McShane and Hobson.

## Historical Tidbit

### Near-fatality in 1924 Rose Parade

From the Springville New Era, **Jan. 17, 1924:** "Gene Carbee, a former Springville boy, and a son of John Carbee, narrowly escaped death on New Year's Day when he was





overcome by gas while driving a float in the Rose Tournament Parade in Pasadena, Calif. The parade had been halted, and when ordered to move on, Gene's float failed to go. Upon investigation they found him unconscious. He was rushed to a hospital... The doctor at the hospital told Gene that two minutes more of the gas would have been fatal."

#### City Council Minutes – January 6, 2014

Mayor Heeren called the regular meeting of the City Council to order at 6:00 pm in Springville City Hall. Present on roll call: Miller, Brady, Hoyt, and Sindelar. Absent: Mareta Ralston. Also present: Brandon French, P.J. Hoyt and Karen Anderson.

**Consent Agenda:** M/b Brady, 2<sup>nd</sup>/b Hoyt to approve the consent agenda as posted. All ayes, motion carried.

**Citizens With Concerns Not on the Agenda:** none.

**Sheriff's Report:** none.

**Maintenance Report:** Brandon reported grave opening and plowing snow have taken up most of their time.

**Clerk:** provided the 2013 gross wages report, December overtime report, FY 2013 annual financial report to the council for their review.

**Old Business: Casey's Building Update:** Atty. Taylor provided a *Waiver of Conflict of Interest* in reference to the Casey's real estate transaction between the City and Grimleys. Both parties are using the same attorney. M/b Brady, 2<sup>nd</sup>/b Miller to approve said agreement for transfer of the Casey's property utilizing a single law firm, that being Klinger, Robinson & Ford LLP, to represent both parties in the transaction. All ayes, motion carried.

**Trail Grants:** Council members received a Statement of Qualifications from MSA in reference to the company's qualifications in securing grant funding and providing engineering services for recreation trails. The council can chose to hire MSA as the consulting firm for a trials project or proceed with a request for proposals (RFP) process. MSA will attend the next council meeting for a discussion with the council.

**New Business: Release of Housing Rehab Mortgage:** The homeowner at 306 North Avenue was the recipient of a housing rehab grant. Rehabilitation activities have been completed and a mortgage in the amount of the construction costs has been recorded against the property by the City in accordance with the Administrative Plan adopted by the city in accordance

with IDEA. The property owner has attempted to re-finance the house at a lower interest rate and the bank will not re-finance with the recorded mortgage in place even though there is no interest due, no payments and will be forgiven in 5 years. Liz Kemp (housing rehab administrator) proposes that the City release the current mortgage in order for the homeowner to secure the re-financing. Once the loan is finalized the City and MSA will be notified so that another mortgage can be recorded for the amount of the home revitalization. The Homeowner is to pay any costs related to the mortgage release and subsequent recording of the second mortgage. M/b Hoyt, 2<sup>nd</sup>/b Sindelar, approving said request of homeowner at 306 North Avenue. All ayes, motion carried.

**Fire Station-Furnace Failure:** The furnace at the fire station quit running on Friday. Comfort Solutions was called and related that the 27 year old furnace needed to be replaced. A 95.5% energy efficient furnace replaced the defunct furnace. Total cost of the new furnace and air conditioner for the fire station was \$4,541 with a \$400 rebate from Black Hills Energy.

**Tax Abatement:** tabled.

**Oath of Office:** P.J. Hoyt was given the Oath of Office for a 3 year term as Fire Chief.

**Committees & Appointments:** Mayor Heeren designated the following appointments and committees: **Mayor pro-tem;** Mike Brady, **City Clerk/Treasurer, Flood Plain Administrator and Zoning Administrator;** Karen Bixler, Public Works Director; Todd Wyman, **City Attorney;** Anne Loomis, **Sheriff's Department;** Linn County, **Fire Chief;** Patrick Hoyt, **Newspaper;** CR Gazette, **City Engineer;** Shoemaker & Haaland & MSA Professional Services, **Budget & Finance;** Hoyt, Ralston, Heeren, Bixler, **Board of Adjustment;** Miller, **Economic Development;** Bixler, **EMA;** Heeren, **Library and School liaison;** Sindelar, **Personnel;** Miller, Heeren, Brady, **Parks;** Sindelar, **Policy;** Bixler, Brady, Heeren, Hoyt, **Fire Dept.;** Brady, **911 Board;** Hoyt, **Cemetery;** Bixler, Koppenhaver, Brady, **Zoning Representative;** Miller.

**FY 2014-15 Budget:** Bixler informed the council that she would undergo back surgery on February 14<sup>th</sup>. Her goal is to have the budget finished before that time. Discussion was held on notifying all the departments so they could complete their budget in a short period of time. Susan and Karen will man the office during Bixler's recovery.

**Correspondence:** DOT announcement that state initiatives to permit use of marijuana for so-called "recreational purposes" will have no bearing on the DOT's regulated drug testing program. Also, a drug test will not be verified negative based upon information that a physician recommended the employee use "medical marijuana" when states have passed medical marijuana initiatives

**Next meeting:** Monday, January 20, 2014 at 6:00 pm.

#### City Council Minutes – January 20, 2014

Mayor Heeren called the regular meeting of the City Council to order at 6:00 pm in Springville City Hall. Present on roll call: Miller, Brady, Hoyt, and Mareta Ralston. Sindelar was absent. Also present: Todd Wyman, Dave Raue, Roger Shebetka, Mat Sauer, John Keizer and Elizabeth Kemp via speaker phone.

**Consent Agenda:** M/b Brady, 2<sup>nd</sup>/b Hoyt to approve the consent agenda as posted. All ayes, motion carried.

**Citizens With Concerns Not on the Agenda:** none.

**Sheriff's Report:** A deputy delivered the Sheriff's report for January 06, 2014 through January 20, 2014. There were 17 calls for service. December total hours of service: 139.

**Maintenance Report:** Todd provided the council with the maintenance report that consisted of plowing and sanding streets, working on the electrical problem in Well #3 – Hoddy Gates will be out next week to access the problem. Also, mixing sand and salt, thawed out a stop box on High Avenue, snow equipment maintenance and took down Christmas decorations and banners and replaced with gazebo banners. In the water and sewer utility, yearly samples were taken for

atrazine and simazine, quarterly raw samples were taken, MOR samples for water and sewer and Bac-T samples. The department continues to work on keeping the streets cleared. Todd will be working on FY 2014-15 budget and helping the engineers with the Broadway Street project.

**Clerk:** provided the council 2014 committees and appointments listing, December library board meeting minutes and finance report, park and fire department quarterly reports.

**Public Hearing (7:00 pm):** Status of Funds for the Housing Rehabilitation Program. Liz Kemp gave a program overview to the council. The CDBG programs goal is to rehab properties to meet Iowa minimum rehabilitation standards. This consists of a five year forgivable loan. The overall budget was \$244,994, inclusive of a \$10,000 contribution from the City. The program calls for rehabilitation of 6 LMI homes with a rehab budget off \$24,999. This does not include lead-based paint remediation or relocation funding. Five homes have been rehabbed with one home going to contract ASAP. There are remaining CDBG funds of \$20,884 for rehab, \$4,901 for lead-based paint and \$1,050 for relocation (if warranted). This funding will be offered to those applicants whose property has been inspected and complied with standards set for program funding. The program completion date is May 31, 2014. Mayor Heeren asked for oral or written comment on the housing rehab program, there being none he closed the Public Hearing at 6:08 p.m.

**Old Business: Trail Grants:** Mat Sauer of MSA was present to discuss a proposal for a Springville trail corridor feasibility study. Sauer noted that the City had previously completed a basic planning for entrance, trial and park improvements in the community in 2004 thru a partnership with the Iowa’s Living Roadways program. The feasibility study would be the first step in bringing these concepts to fruition. M/by Brady, 2<sup>nd</sup>/by Miller to approve a lump sum scope of services in the amount of \$9,195. All ayes, motion carried.

**New Business:**

**Hall & Hall Cemetery Monumenting Contract:** Correspondence was received from Ryan Remling of Hall and Hall Engineers informing the Council that the City is at or near the \$4,000 estimate for the contract for monumenting Blocks 7, 9, and 10 of the cemetery. Remling suggestion was to finish Block 7 and then discuss what to do about Blocks 9 and 10. Discussion was held on the infrastructure needs to be able to utilize those 2 blocks. It was noted roadway need to be put in, the back row of trees taken out and the dirt pile would need to be removed and another place established to contain the extra dirt. Remling will be notified the Council agrees with his suggestion and will consider the project completed with monumenting of Block 7 at this time.

**Approve Tax Abatement Request:** M/by Brady, 2<sup>nd</sup>/by Hoyt to approve the application for tax abatement in Spring Meadows 3 subdivision submitted by Terry Caudill and Darci Dullea. All ayes, motion carried.

M/by Brady, 2<sup>nd</sup>/by Miller to approve **Resolution #1-2014: A Resolution Authorizing the City Clerk of the City of Springville, Iowa to Transfer \$16,771 from the Fire Trust Fund to the General Fund in Fiscal Year 2013-14.** Roll call vote, Sindelar absent. Remaining ayes. Motion carried.

**Correspondence:** none.

**Next meeting:** Monday, January 27, 2014 at 6:00 pm. M/by Miller, 2<sup>nd</sup>/b Ralston to adjourn at 7:06 p.m. All ayes, motion carried.

**Tell a Tale of Iowa – The Lynching at Harlan**

A young man was caught and his companion killed by a posse in “Buck’s Grove,” in Shelby County, after they had murdered a Marne, Iowa man. Crowd of around five hundred gathered at the edge if the woods after the capture and demanding a hanging. A rope was placed around the fugitive’s neck and he was taken to a large bridge for the execution. Just Sheriff Rainbow of Shelby County rode up and talked to the crowd, asking that the boy be allowed to stand trial and let the law take its course. Seeing the mood of the mob and the futility of reason, Sheriff Rainbow decided to outsmart them. He stood on a wagon in the middle of the bridge and announced he would take a vote. All those who were for hanging were to gather at the east end of the bridge; those against, at the west. Then, as the crowd moved to the east to vote for lynching, the sheriff lashed the horses into action and, with the frightened youth, took off in the opposite direction and safely beat the crowd to Harlan. Here the prisoner was lodged in the county jail. However, the sheriff’s quick thinking was to no avail Late that night a chanting mob stormed the jail and carried the struggling youth to a nearby woods. There, in the eerie light of a full moon, the boy was strung up to the limb of an old oak tree. In the eyes of frontier Iowa, justice had been rendered and a wrong avenged – all at the end of a length of a rope.

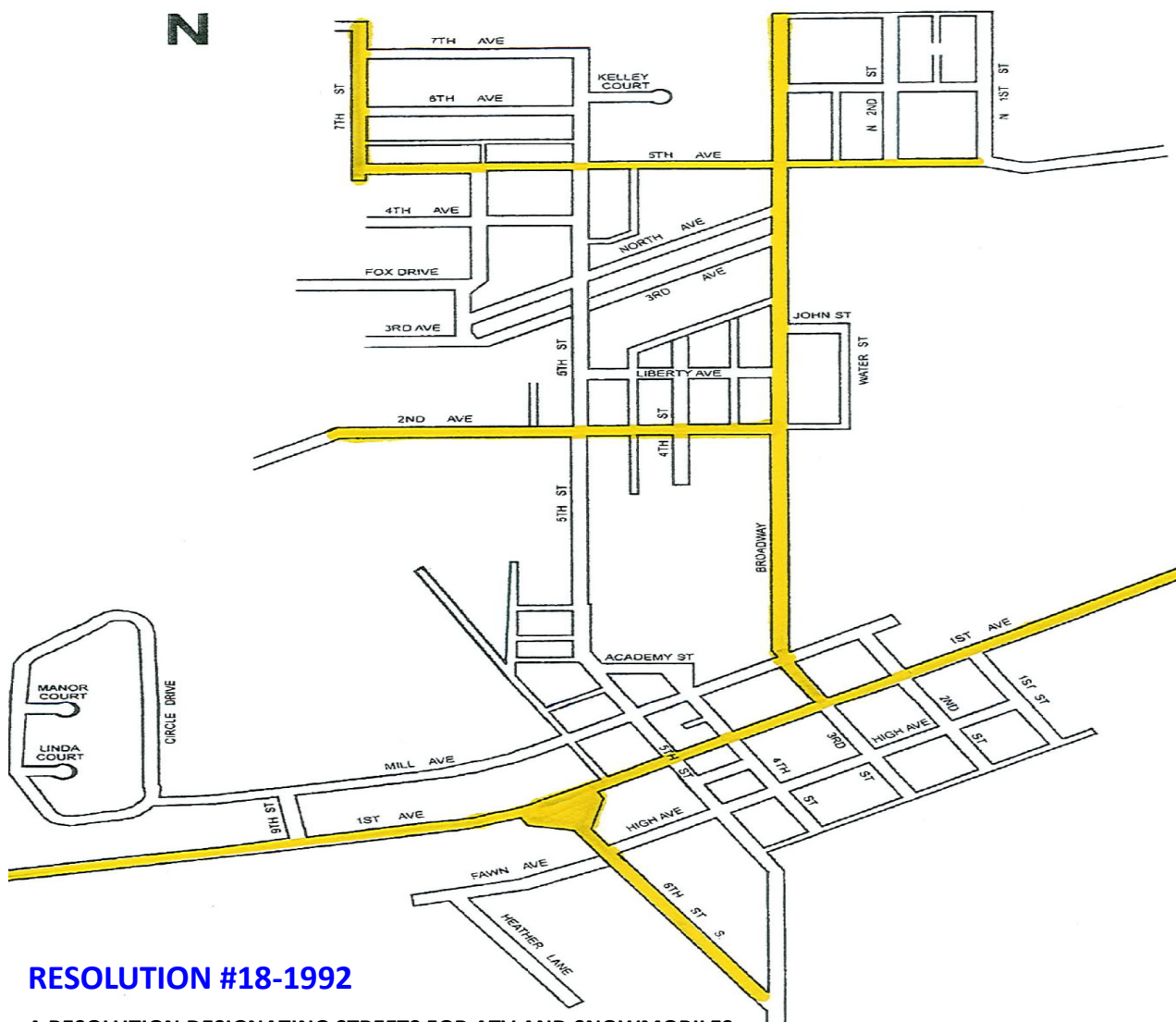
