




Please be safe this winter season and stay off of Cox Pond. This pond does not freeze solid due to the aerator that is in there. Please warn all your children to stay off the ice.

For year two of Oriole Pride Week, a week of project-based learning at the Springville middle and high school, the public got a chance to see what the middle schoolers had been working on Jan. 10 as they entered the gym for their Living History Museum.

Middle schoolers dressed up in the guise of famous figures from history, talking in the first person. The figures ranged from religious figures, to athletes and anyone in between. What attracted each student to their subject could vary wildly.

Jayce Ernzen, and Jack Stamp did their projects on Jerry West and Magic Johnson, respectively, because of their love of basketball. Katrina Laubengayer decided to do her project on anthropologist Margaret Mead and had a unique inspiration for choosing her subject.

"I found a really catchy song on YouTube about anthropology," she said.

Sierra Werling chose Amelia Earhart as her subject, fascinated by the first woman to fly solo across the Atlantic Ocean. For Ryan Foley, studying George Lucas meant he not only got to study one of his icons, but also study the field he hopes to enter in the future, with dreams of being a director.

The days were broken up into halves, with the first portion focusing on a conceptual project and the second half of the day focusing on a service project.

By far the most popular project for the high school students was the "master chef" program, which attracted 60 students. They worked in teams of six to develop a three-course meal to serve to the judges. The winning meal of meatballs, buttery-herb mashed potatoes and yogurt parfait, was served as part of a community meal held Jan. 9 at the high school. The judges were complimentary of every aspect of the meal.

The meal included samples from honorable mentions from other dishes created by students: a main dish pad Thai, a side of Tom Yum Goong Soup and a dessert of mango ice cream.

Other projects from the week included creating a Rube Goldberg machine and studying fair trade.



A STROLL THROUGH THE HIS

Fannie Branch Abbott: from Liberty Avenue to . . . where?

In November 1831, Fannie C. Branch was born in York Township, Medina County, Ohio. Her parents were Lawson and Cordelia Phillips Branch.

Fannie lived 23 years in Ohio; 12 in Clayton County, Iowa; and at least 38 in Springville and vicinity. The last record found is a March 1904 property sale when she was 72.

The wedding of Fannie Branch and Charles B. Abbott took place in 1850. They had four daughters and lost another child. Firstborn Alice was 20 when her sister Anna Belle was born. Between them were Marion and Etta, called Ettie.

The family moved from Clayton County to a farm west of Springville in 1865. Alice was 14, Marion 9, and Ettie 5. Anna was born in 1871, the year Alice had her second baby. (Alice married Wallace Hakes in 1868.)

Charles Abbott was badly hurt in a runaway accident on Springville's south side in August 1880. A wheel passed over his head, but he lived two and a half years after that. He died March 3, 1883, five days before his 66th birthday, leaving Fannie a widow at 51.

In 1895, Fannie, her daughter Ettie Willard, and Ettie's children, Claude Sigwalt, 16, and Pearl Willard, 9, were sharing a home in Springville. Claude graduated from high school in 1898. In November 1899, Fannie Abbott bought a house from Hannah Gritman at 405 Liberty Ave.

Ettie Willard ran a boarding house there, according to a 1928 Springville New Era story. The 1900 census listed her as a dressmaker, but there was one boarder, William McAtee, 53.

Fannie sold the house in March 1904 to Ora and Mae Gibson Chenoweth. Fannie's whereabouts after that are a mystery. Charles Abbott is buried in the Springville Cemetery, but Fannie's name is not found there.

FOUR ABBOTT DAUGHTERS: Alice Abbott married Wallace D. Hakes and lived in the Crabapple area west of Springville. Marion Abbott was the wife of Charles E. McShane; they lived in or near Springville. Ettie Abbott had three husbands: Edward Sigwalt (he died less than three years after their marriage), Lewis Willard (they apparently divorced), and Edward L. Iverson. Ettie moved to Crook County, Oregon. Anna Belle Abbott married David Van Patten; they moved to Enumclaw, Washington.



This house at 405 Liberty Avenue was once owned by Fannie Abbott, a widow. It was built in 1871. In its first 28 years, it was a school, a Quaker meeting house, and a Young People's Endeavor clubhouse. Fannie bought it in November 1899 and remodeled it for a residence.

TORY OF SPRINGVILLE, IOWA

Underground Railroad operated near Springville

Just a few miles northeast of Springville, the Underground Railroad was quietly active in the decade before the Civil War. Probably few, if any, Springville people were aware that Quakers in the rural Hopewell area were involved.

There was good reason for secrecy. The federal 1850 Fugitive Slave Act imposed harsh fines and prison sentences on people who helped slaves escape – even in states such as Iowa where slavery was illegal.

William Pearson Dewees, a Hopewell farmer, was part of the Underground Railroad. His role was disclosed in a book published 36 years after the Civil War ended: the 1901 Biographical Record of Linn County.

"Mr. Dewees . . . was a strong abolitionist, and was a conductor on the famous underground railroad . . . (assisting) many a poor slave on his way to Canada and to liberty," states the book. "In company with a few other white men, he aided as many as 17 negroes on their way north one night."

Quakers, known for their firm anti-slavery stance, began settling at Hopewell in 1851. William and Maria Embree Dewees, both 28, arrived from Morgan County, Ohio, in May 1853, the year after they were married.


They bought 40 acres of prairie and 20 of timber. Over the years, the farm grew to 160 acres. The Dewees family grew to six children: Matilda, Isaac, Joseph, Barclay, James, and Mary. Their log cabin was replaced in 1875 by a frame house.

William and Maria were described in the 1911 History of Linn County as "consistent Christian people whose many excellent traits of character endeared them to all who knew them."


Maria, 57, died in September 1882. Later William married Elizabeth Gilbert Bedell, a widow. They lived in Springville. After Elizabeth's death in 1895, William lived at Hopewell with his son Joseph and daughter-in-law Lucetta.

On Sept. 24, 1901, William P. Dewees died at 76. The Hopewell meeting house, site of his funeral, was later closed and shipped to Paullina, in northwest Iowa. His grave is in Hopewell Cemetery, along Quaker Lane.



The Springville City Council met in regular session in the Springville Council Chambers on January 6, 2020. Mayor Shebet-ka called the meeting to order at 6:00 p.m. Council members present: Dennis Thies, Brad Merritt, Jeff Grimley, Lyle Andersen, and Karla Blakely. City Staff present: Public Works Director Todd Wyman and City Clerk/Treasurer Dee Wagaman. Guests present: Patrick Hoyt Jr., Jeremy Ketelsen, Treva Davis, and Susan Cooper.

Sheriff Tindal presented the Linn County Sheriff's report. There were 27 calls for service between 12/16/19-1/6/20.

Thies made a motion to approve the agenda, second from Andersen. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of December 16, 2019 minutes and Approval of bills, second from Grimley. All ayes. Motion carried.

Mayor Shebetka invited citizens with input to speak. There being no comments from citizens, Mayor Shebetka moved to business.

Wagaman explained the new lowa Code requiring a public hearing on the proposed property tax levy. This maximum does not include all the levies that the City will be proposing. Andersen presented Resolution 134-2020, a resolution to set a public hearing on January 20, 2020 at 6 p.m. to present the maximum tax levy, second from Blakely. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Blakely. RESOLUTION 134-2020 adopted.

Thies made a motion to approve the FY21 28E agreement with the Linn County Sheriff for \$37/hour for 80 hours a month, second from Andersen. All ayes. Motion carried.

Andersen made a motion to approve the tax abatement for 708 Heather Lane, second from Grimley. All ayes. Motion carried.

Merritt made a motion to approve the tax abatement for 704 Heather Lane, second from Thies. All ayes. Motion carried.

Discussion on placement of City defibrillator. Library is requesting it in their facility. Andersen made a motion to place the City defibrillator in the Springville Memorial Library, second from Thies. All ayes. Motion carried.

Discussion on Springville Historical Society door repair. Wyman will look at the door to see what it will take to repair. This will be on the next agenda to discuss costs and options.

Andersen presented Resolution 135-2020, a resolution to approve new signatory cards for The Exchange State Bank, second from Blakely. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Blakely.

Andersen presented Resolution 136-2020, a resolution to approve new signatory cards for Security State Bank, second from Thies. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Blakely.

Wyman presented written report.

Wagaman presented written report and treasurer reports. Discussion on when to have budget workshops.

Mayor Shebetka thanked the council and staff for the plant for the death of his sister. It meant a lot for him to have that support.

The first budget workshop will be January 15, 2020 at 4:30 p.m. at City Hall.

The next regular council meeting will be January 20, 2020 at 6:00 p.m. at City Hall.

There being no further discussion, Blakely moved to adjourn at 6:40 p.m., second from Andersen. All ayes. Motion carried.
