

I am not sure who asked for all this snow, but we sure got a lot in January. It is very apparent when you drive around town and see all the piles. The guys are working hard to get the piles moved. Just take extra caution when going around corners. The visibility will be limited for awhile.

My office has been pretty busy with all the year end reporting and new budgets. If you ever have questions about your City budget, please don't hesitate to call me. I am always happy to explain how things are going.

SEDC is helping the City by participating in a Rural Housing Readiness Program. This group met with the guidance from the lowa State University Extension & Outreach along with MSA (engineering firm). The first step in this process is to hear from the public. There is a survey online that we would love for you to fill out. You can find more information about this survey below. This program will help define what the community wants/needs for housing.

I have a few reminders; please do NOT blow or shovel your snow into the street. This just causes more work for the City crews and your neighbors. Also, when there are snow emergencies, please keep your vehicles off the street as long as possible. The first pass of the plow is to make the streets passable, then the guys go back around to get the streets widened and if cars are there they can't get that done. Your cooperation helps us, and also helps keeps your neighbors happy.

Sadly, our office is still closed to the public. We are here during normal business hours to help with anything you need. We have been able to do most things electronically or appointments. Now that the vaccines are getting out there, maybe we will be able to see you soon!!



Three known families occupied former school, 1901-2014

A brick house at 402 High Ave., vacant for the past bride June 2, 1907. Following were the weddings seven years, will be demolished in February, joining the ghost structures of Springville's history. It's vine, 1926. Muriel remained single. The only son, likely the oldest building in town – nearing 156 years.

From 1865 (when it was built) to 1882, it was a school for Grades 1 through 8. Then for about 131 years it was a residence. Three families are known to have lived there over a 108-year span: Romans, Mertka, and Crane.

Joseph and Rachel Calvert Romans moved in with their seven children in February 1901. An eighth child, Irvine Leah, was born in January 1904. Her sister Blanche, 12, died of a ruptured appendix February 12, 1905.

Five of the six remaining daughters were married in the brick home. Mae became the first Romans

of Ethel, 1916; Edith, 1920; Velma, 1922; and Ir-Claire Joseph, lived in Williston, N. D., as an adult.

Joe and Rachel Romans moved to Cedar Falls in 1945 to live with their daughter and son-in-law, Ethel and John H. Peet. For a few years after that, occupants of the brick home are unknown.

In the late 1940s, Maxine Hughes Mertka and her four children moved there from another home on High Avenue. Their husband and father, Louis Byron Mertka, had died April 16, 1948. He was 38.

The Mertka children, all born in the 1930s, were Marlene Carpenter, Louis Jr. (called Bud), Charlotte Dunlap, and Carl "Buzzy." Their mother's

TORY OF SPRINGVILLE, IOWA

Griffith, Springville carpenter, built a house on Fifth Avenue

Springville's former brick school on High Avenue was Ron Crane's childhood home. Now he lives in another house with a known history. It was built at 404 Fifth Ave. by bachelor carpenter Euclid C. "Euke" Griffith.

Euke was born December 19, 1866, on a farm northeast of Whittier in Section 5 of Brown Township. His parents were Milton Griffith Sr. and his second wife, Sarah Broomhall. Milton died in 1876, when Euke was 9 or 10. He was the youngest of Milton's eight children

Euke had five half siblings and a full brother and sister. One half-brother, Milton Jr., died of disease in New Orleans while serving in the Civil War, before Euke was born.

In 1885, Euke and his mother moved to

Springville. Euke attended high school two years, then quit and became a carpenter. Possibly around 1900, he built the house on Fifth Avenue for himself and his mother. Sarah, 88, died in June 1915.

Euke was remembered as an excellent carpenter who had a problem with strong drink. At 73, he took his own life July 20, 1940. His grave is in the Springville Cemetery.

second marriage, to A. J. Boomhower, ended in divorce and she resumed the name Mertka.


About 1964, Mrs. Mertka left the brick house. For 30 years, she lived with her son Carl first in Central City and then in Marion. She died in 1994. Three of her children are deceased; Charlotte Dunlap lives in Cedar Rapids.

Last to occupy the venerable Civil War-era structure were **Robert and Patricia Babak Crane** and their five children, who had previously lived in a house across the street to the east. The first indoor bathroom in the brick house was installed just before the Cranes moved there in summer 1966. They lived there nearly 48 years. In January 2014, Bob and Pat moved to another High Avenue house.

Mrs. Crane died November 8, 2020; her husband continues to live on High Avenue. The Crane children are Cathy Horak of Marion; Julie Mann, Marengo; Brian, Central City; Ron, Springville; and Dennis, Dallas Center.

Back to 1901: The Romans family bought the brick house from someone named Nash, according to the Springville New Era. Isaac Nash, a veteran of both the Mexican War and the Civil War, lived in Springville from 1896 until his death in 1917. Whether he and his wife Mary Ann lived in the old school has not been verified.

On March 19, 2020, Governor Reynolds issued a Proclamation of Disaster Emergency, which included a suspension of Iowa laws that would prevent the use of electronic meetings or the limitation on the number of people present at an in-person meeting site. The agenda had this message posted more than 24 hours in advance to give instructions on how others could participate in the meeting: Based on COVID-19 guidance from Linn County Public Health and the State of Iowa to limit the size of groups gathering, this meeting can be viewed online. 
