HAPPY NEW YEAR



Winter weather is here. There are many issues to remember concerning snow and ice. Be sure to drive and walk carefully, slick conditions are beyond our control and can set in very fast. If you don't have to be out during a storm, please stay in and stay safe. The City crew goes out to work on the streets when the snow accumulation reaches two inches, is blowing or drifting to affect traffic, or there are icy conditions, that need sanding.

Please remove all vehicles from the street parking areas during a winter storm. Don't place them back on the street until the snow has stopped and the street has been plowed. The snow plows are much more effective

when they can pass through the street easily and straight along the side of the road. Vehicles on the street must be moved every 24 hours, regardless of weather conditions.

It is the responsibility of the abutting property owners to remove snow, ice, and accumulations promptly from sidewalks. If a property owner does not remove snow, ice or accumulations within 48 hours, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax. Be kind to walkers and help make their pathway clear. Snow from private driveways and sidewalks must be placed onto private property. It is not safe to plow or blow the snow onto an open road. It does make the travel conditions on the road worse and can damage city equipment and vehicles.

The snow plows deposit the snow along the side of the road, this means that you will have snow placed in the area of your driveway, mailbox, and sidewalk. The post office will not deliver your mail unless the driver can access the mailbox. The City may make multiple passes to keep the street area clear. This may require you to clean these areas more than once for each storm, there is no way to avoid this snow placement. When you remove the snow, do not place it back in the street or on someone else's property. You are liable for the snow at the front of your property. Make sure there is proper visibility for vehicles when on the street and pulling out onto the street.

Please be sure to tell your children to stay away from the snow plows. These are large pieces of equipment and visibility is sometimes hard. No one wants a child injured. Children should not be allowed to play in the snow in the area between the sidewalk and the curb; and certainly not in the street. There have been reported deaths in other communities. When the snow plows pass, they can cave the snow in and bury children in forts.

DO YOU REMEMBER WHEN...

18 centenarians with Springville ties; earliest was born in 1845

Eighteen centenarians have lived in the Springville area; thirteen reached 101 or beyond. Faye Chalupsky Armstrong of Marion turned 103 Sept. 6, 2016. She believes it's important to "keep going," and takes a keen interest in local and world events. A 1931 graduate of Blairstown High School, she met Paul S. Armstrong at a dance. They were married in 1934 and farmed east of Springville. He died in 1982.

The newest centenarian was also a farmer – near Paralta as a child; New Boston, Ill.; and north of Springville for 70 years. Aubrey McShane turned 100 Nov. 15, 2016. A 1935 graduate of Springville High School, he is the oldest alumnus. Aub gardened into his 98th year. He and his wife, the former Lorean Spacek, moved to Anamosa in 2015.

The earliest centenarian, Mary Gregg, came from Ohio in 1853, likely in a covered wagon. Her Quaker parents, Caleb and Millicent Doudna Gregg, settled in the Hopewell area east of Springville. At 22, Mary wed George H. W. Copping, Civil War veteran and native of England. They moved to Pasadena, Calif., in 1906. Mary turned 100 Sept. 1, 1945, and lived to 102.

John P. Williams, born in 1892, was adopted at age 3 by Aaron and Elizabeth Barber Williams, who farmed near Whittier. His birth parents were Ezra and Anna Embree. John married Edna Willits and, after her death, Ardith Emmons. In 1993, he died at 100 in Greensboro, N. C. His son is Bob Williams, 95, of Whittier.

Sisters both reached 100

Two centenarian sisters were Margaret Gearhart Johnston, 101, and Laura Gearhart Smith Fagle, 100. Their physician father, Dr. George W. Gearhart, died in 1969 at age 97½. Margaret stayed in Springville all her life; her husband Lee Andrew "Andy" was mayor. Laura moved to California as an adult.

The oldest of the 18 was born in 1900 at Cantril in Van Buren County. Mary Hoskin, widowed four times, reached 107. She married Springville dentist Dr. Claude C. Wells in 1936; each had lost a first spouse. Her fourth husband was Arthur "Art" Pearson of Whittier. Mary's other married names were Peck and Wentzel. She died at Dubuque in 2007.

Alta Stentz McGrew and Elizabeth Holubar Yeisley both lived to 105; Marguerite Taylor Upham, 104; and Leone Wolmutt Coons, Gladys Hindman McShane, and Mary Port Perkins, all 102. Mabel Campbell Bennett, Helen Roselle Fernow, and Sarah Battey Hall reached 101. Jackson W. Bowdish and Nira Benton Smith were 100.

Mary Clark Boots, an Illinois native, died on Christmas Eve 2000, just 29 days short of her 100th birthday. Springville residents of a certain age will remember her hardware and gift shop on Broadway from 1950 to 1971. The late Steve Shaffer was her grandson.

Historical Society will meet January 10

The Springville Area Historical Society (SAHS) will meet Tuesday, Jan. 10, at 6:30 p.m. in the SAHS building beside City Hall. Anyone interested in local history is welcome to attend.

At the Dec. 13 meeting, vice president Wes Bender reported completing an SF-180 request form to obtain the service record of Korean War casualty Robert L. Newman. It must be submitted by a relative. Kim Davis Shipley of Cedar Rapids, Newman's cousin, is doing so.

A 1948 graduate of Springville High School, Newman was lost at sea in a Navy plane crash off the coast of North Korea Dec. 26, 1952. SAHS hopes to obtain a government memorial marker for the Springville Cemetery.

Noting the anniversary of Iowa's statehood Dec. 28, 1846, historian Karen Taylor discussed 1846 events in Springville. The meeting then adjourned for the annual Christmas party. Others attending were James Crow, president; Bev Franks, Bob and Shirley Parker, Phil and Karen Randall, Pat Rose, Alan Safley, and Duane Schlatter.

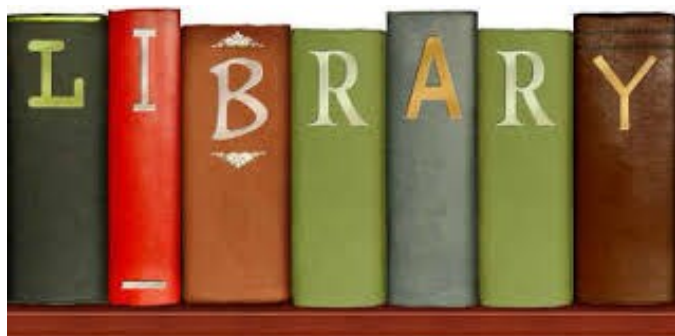
Butler kin at Paralta, Mechanicsville

When Isaac Butler came to Brown Township in 1840, his nephew James Shintaffer apparently was living nearby. James and his wife Rachel's daughter Mary Ann, 5, died April 6, 1840, and was buried in Paralta Cemetery south of Springville.

Mary Ann's grandmother was Isaac's sister, Nancy Anne Butler. She married Phillip Shintaffer in Greenbrier County, Va. (now West Virginia) in 1802. That couple's son, James Shintaffer, married Rachel Garver in 1832 in Michigan, and they moved to Iowa.

Mary Ann Shintaffer was survived by siblings Eleanor, 8, and Isaac, 6. Daughter Nancy was born in 1840, followed by six more children. The family moved to Cedar County, Iowa, in 1841, and to Daviess County, Mo., in the 1860s.

Also in pioneer times, Isaac Butler's niece lived near Mechanicsville. Eleanor Shintaffer had married Samuel Soesbe in Indiana. Three children were born there, two in Michigan, and four in Iowa. Eleanor died in 1850 when her youngest was a baby.

We also send our books all over Iowa to other libraries and get a reimbursement from the State Library, overall this program is a win-win for all involved.

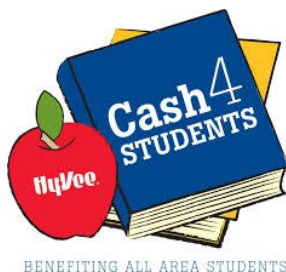

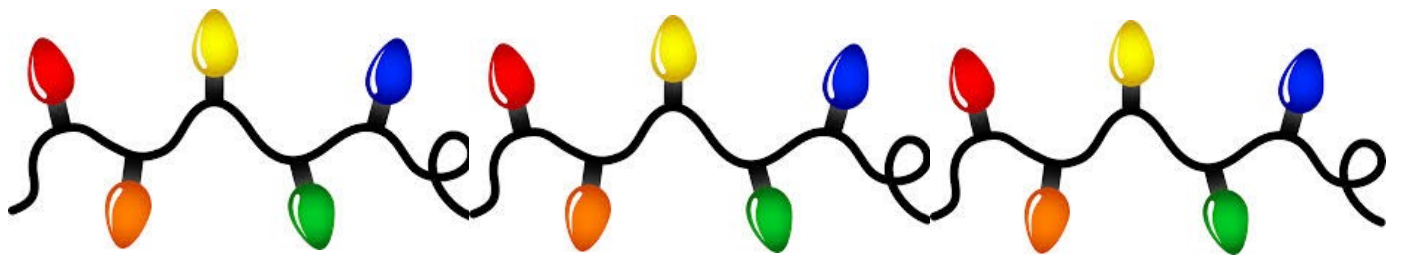

**SPRINGVILLE CITY COUNCIL
Regular Meeting Minutes
December 5, 2016**

Mayor Roger Shebetka called the regular meeting of the Springville City Council to order at 6:00 pm in Springville City Hall. Present on roll call: Councilpersons- Dennis Thies, Brad Merritt, Pat Hoyt, Penny Sindelar, and Mareta Ralston. Also in attendance was Public Works Supervisor Todd Wyman, Jennifer Wyman, Dave Raue, Jean Menster, Treva Davis, Theresa Merritt, City Attorney Mark Parmenter, and City Engineers Jay Vavra and Tom Anthony.

M/B Thies, to approve the consent agenda, 2nd/B Sindelar, all ayes, M/C.

Sheriff- Deputy Egli reported 140.9 hours logged with 22 calls. Some discussion with council on areas of patrolling in town and suspicious activities, council would like to see the temporary stop signs by the school on 5th Street patrolled in the mornings.

Mayor- Mayor thanked the Tractor Pullers for selecting, hauling, setting up, and decorating the Holiday Tree in Butler Park. On December 19th, the Council will host a holiday party, here in the Council Chambers at 6:00 pm. Everyone is welcome.

Councilpersons- Councilman Hoyt asked if the homeowner building an accessory shed got his permit and all was taken care of, yes it did.

Mark Parmenter our City Attorney and Jay Vavra and Tom Anthony our City Engineers with Shoemaker and Haaland were in attendance to aid in the discussion and possible action on Water Street. Tom presented a preliminary plat of the intersection of Water Alley and 2nd Avenue, enough property pins were located to draw the plat. Tom suggested setting the remaining pins, and then he would sign a final plat, that would be recorded with the county. Lengthy discussion followed on retainer walls and height, the creekside, legalities, the DNR requirements, and more. Jay will get some cost estimates of all expenses. M/B Merritt, directing Shoemaker and Haaland to set Property Pins per the preliminary plat, and with P and Z blessing, it will be approved and recorded as a Final Plat with Linn County, 2nd/B Thies, M/C. Other discussion on this topic included, is the alley to narrow by code, is the alley grandfathered as its creation at current width dates back to before the current codes, ever considered permanently closing the alley, biggest concern is the dangers of pulling out onto Broadway from city parking lots, all efforts will come down to feasibility. More discussion at the next meeting. City Engineer Tom Anthony led the discussion with possible action on the 5th Street Reconstruction Project and the current surveying. Tom presented a mapping of the most recent surveying discoveries, told of research discoveries, and did some comparison to the County's GIS mapping and explained the differences. There was lengthy discussion on codes as they compare to the discoveries, the new elementary as it relates to the street, right of ways, and personal properties. M/B Sindelar, directing city engineers to perform the topographical survey and proceed with preparing the design plans for 5th street 2nd/B Ralston, all ayes, M/C. Clerk to contact the 5 homeowners that were previously contacted with possible property concerns along 5th street, and update them on surveying results. Discussion on Parks Board renewal of a CD, and wanting to label this monies as "Gazebo Repair Fund", council has no problem with this, Park Board can make this decision. Todd's maintenance report included- Roto Rooter has been out to camera the sewer lines, had some problem with roots, so had to clear them first. All sewer lines look good, should be able to line with no problems. Citizens did a very nice job moving vehicles off the street after the snow, so we could clear. Met with MSA engineer about lift station and new generator. Put holiday decorations up. When 5th street construction begins, homeowners will be given the opportunity to make water and sewer repairs as the project passes their property. Tabled Ordinance #10-2016, an ordinance restricting parking on 1st Avenue.

Discussion on project Funding. Clerk reported no area banks and credit unions interested in financing our projects. Clerk recommended using SRF funding for sewer and water, council agreed. Talked with Nate Summers of DA Davidson, he would recommend a General Obligation Note for the streets. Need to get with Mat Saur to create a timeline, so then will figure funding options.

M/B Merritt, to move the January 3rd Council Meeting to January 9th, 2nd/B Thies, all ayes, M/C. M/B Sindelar, to adjourn at 8:00 pm, 2nd/B Merritt, all ayes, M/C.

December 19, 2016**

Mayor Roger Shebetka called the regular meeting of the Springville City Council to order at 5:30 pm in Springville City Hall. Present on roll call: Councilpersons- Dennis Thies, Brad Merritt, Pat Hoyt, Penny Sindelar, and Mareta Ralston. Also in attendance was Public Works Supervisor Todd Wyman, Jennifer Wyman, Barb Shebetka, Robin Ballantyne, from MSA Joe Elsinger, Liz Kemp, Matt Cloos, and Mat Saur, from Shoemaker and Haaland Bob Tobin, Jay Vavra, and Tom Anthony, Lyle Anderson, Jim Koppenhaver, IrisTrampe, Theresa Merritt, and City Attorneys Mark Parmenter and Megan Dimitt.

M/B Thies, to approve the consent agenda, 2nd/B Hoyt, all ayes, M/C.

Sheriff- Deputy Egli reported 141.5 hours logged with 39 calls, in the month of November.

Mayor- Wished Everyone a Happy Holiday Season.

Councilman Sindelar would like a future agenda item, for the city to declare one weekend in the month of December, as the towns Holiday Weekend.

Liz Kemp was in attendance with documents for the mayor to sign for the CDBG Housing Grant. There will be some final details added over the next few weeks, and the application will be submitted by January 13th. Joe Elsinger discussed findings and gave updates on the sewer rehab project. Discussion on pump sizes, generator size, grant application, and LMI. Jay Vavra with Shoemaker and Haaland, along with Tom Anthony gave updates on Water Street and 5th Street. When the weather cooperates, the new property pins will be installed along Water Street, and the final plat recorded with the County. The surveying of 5th street is progressing; there is contact with the school engineers for coordinating the new elementary entrances and 5th street. Tom suggested getting the landowners possibly effected back together for more discussion.

Todd's maintenance report included some details on the water main break at the intersection of Fox Drive and 6th street. It was repaired live, so no interruption of water supply, or concerns of quality. Have been applying salt and sand to the roadways.

M/B Ralston, to accept Resolution #39-2016, a resolution to record the Plat of Survey for Lot 69 of Jones and Coes Addition, 2nd/B Thies, roll call vote, all ayes, M/C. A copy of the resolution was given to Engineer Tom Anthony for recording.

M/B Merritt, to approve the 2017-18 Linn County Sheriff's Contract for Law Enforcement Services, 2nd/B Sindelar, all ayes, M/C.

Tabled Resolution #40-2016, a resolution to set aside LOST monies in a short term CD.
