On December 14, 2022, all residents with active logins for Front Desk Accounts were sent the email below.

In order to keep on top of security matters, the payment method attached to your FrontDesk account needs to be updated. This needs to be done in order to verify your account information. The updating process is simple. The next time you log into your

FrontDesk account https://springvilleia.frontdeskgworks.com/ you will be prompted to update the payment information. You can use the same payment information you are currently using.

Updating payment information will be necessary before March 31, 2023. Any account which isn't updated by March 31, 2023 will have their payment method suspended. If you haven't already done so, please update your payment method at your earliest convenience to avoid future payment disruptions. Please contact our office at mweinschenk@cityofspringville.us or 319-854-6428 if you have any questions.

The City Clerk's Office will be happy to assist you update your payment method if needed. Please make sure to have your bank routing number and account number or credit/debit care information available so we can enter the information you wish to use. We do suggest using e-check rather than a debit/credit card to avoid incurring a service fee.


Kids could listen to Christmas stories, create a craft and enjoy cookies and juice or cocoa.

UTILITY BILL REMINDER

Water bills are mailed the last business day of the month for the previous month's consumption. Payment is due by the 15th each month. Late notices

are mailed the 16th or next business day each month and a \$15.00 late fee is charged to your account. The City does waive one late fee per year. Water shut offs are scheduled for approximately one week after the late notices are generated.

Beginning January 2023, the City Clerk's office will no longer be making courtesy phone calls, or sending emails, or texts reminding residents that their payment has not been received and water shut off is scheduled. It will be the resident's responsibility to make their payment prior to the shut off date noted on the late notice. Late fees will not be waived for any payments received after the 15th due date with the exception of 1 per year or has been approved by the City Council.

Accounts that have been shut off will be required to make full payment for the amount of the non-paid bill plus a \$50.00 charge (\$150.00 for after hours/holidays) to turn water back on. Payments must be received by City Hall prior to turning water back on.

Hy-Vee Cash 4 STUDENTS

In 2012, the local Cedar Rapids and Marion Hy-Vee Food Stores and Drugstores launched a fantastic fundraiser program for schools called "Cash 4 Students." This

program is intended to help area schools raise muchneeded funding for equipment, supplies, events and anyother special project a particular school is working toward.


How can you help?

Simply save your receipts, and turn them into the school of your choice. The school will then total and submit all receipts to Hy-Vee. For every \$200 submitted, \$1 is earned.

Whether you are a parent, aunt, uncle, grandparent, school volunteer, or friend of a student—everyone is encouraged to participate. With the exceptions of Money Orders, all Hy-Vee receipts from the 13 local Hy-Vee Stores are accepted. This includes: postage, pharmacy, wine/spirits, laundry, Market Grilles, catering orders, general grocery, and gas at the Cedar Rapids and Marion Hy-Vee locations.

You can drop your receipts off at City hall, the Springville Co-op Telephone Company, the Exchange State Bank, the Security State Bank or the Library.

Linn County Board of Supervisors Awards Funds for Emmons Park Matching Grant of \$22,500 Spurs Progress



The Linn County Board of Supervisors awarded the City of Springville \$22,500 in economic and community development funding in August 2022. This funding will go towards the first phase of the construction of Emmons Park in 2023.

The funding includes a one-for-one matching stipulation that must be met by June 30, 2023. The Springville Presbyterian Church has also made a generous donation of \$16,000. They would also like the community to match their donation. Springville resi-

dents and businesses are encouraged to donate to the Emmons Park project online via PayPal (scan the QR code below) or by check made to the Friends of Springville Parks (a registered 501c3 nonprofit). Let's reach the goal of raising \$38,500 (or more) in January!

A STROLL THROUGH THE HIS


Two Cherry families near Springville in 1860s, 1880s

The talent-deprived Cherry Sisters lived near Marion during their career, but four of them spent part of their childhood not far from Springville. Thomas and Laura Rawson Cherry were born in Rhode Island and Vermont. They and their first child, Ellen (Ella) moved to Franklin Township, Linn County, Iowa, before the 1856 census.

In March 1862, Thomas Cherry bought land about 5 miles south of Springville from Robert and Rhoda Boxwell. The 9-acre parcel was south of Dee Lane in Section 16 of Linn Township. The parents moved there from Mount Vernon with Ella, 7; Lizzie, 5; and Addie, 3.

Nathan, Inez, Effie, and possibly Anna Cherry were born in Linn Township. The family moved to rural Cedar Rapids before the 1870 census, and later to rural Marion. Jessie was born about 1872. Neither Inez nor Anna lived to adulthood. The mother died in 1875, the father in 1888. As a teenager, Nathan left – permanently.

On Jan. 23, 1893, Addie, Effie, and Jessie made their stage debut at Daniels Opera House in Marion. They became touring entertainers described as "so bad they were good." Lizzie performed for a short time; Ella stayed home. None of the five married.

A Springville physician, Dr. Clarence Darrow, cared for Lizzie Cherry during her final illness. About 79, she died at St. Luke's Hospital May 11, 1936. Springville's Methodist minister, the Rev. Lamont C. Smith, conducted her funeral at Yocom Funeral Chapel in Marion. The lEffie, died Aug. 5, 1944.

ANOTHER CHERRY COUPLE, probably unrelated, lived near Springville in the early 1880s. Samuel S. Cherry was born in Blair County, Pa., in 1850. A farmer, he came to Iowa and married Susanah Catharine (Cassie) Brown March 9, 1882, in Linn County.

Their daughter Mary was born in March 1883 at Springville. The family moved before the 1885 census to Woodbine, in far western Iowa. A son, Samuel Thomas (called Thomas), was born Jan. 26, 1886. Nine days later, Cassie died at 34. She was buried in the Springville Cemetery.

In April 1890, little Mary Cherry, 7, was interred at Springville. Cause of her death is unknown. The 1895 Harrison County census listed Samuel, age 44; his second wife, Mary A., 41; son Thomas, 9; and daughter Opal, 1. Samuel died Feb. 23, 1895, two days after a tree fell on him. Then there were three Cherry graves at Springville.

Thomas grew up and married Blanche Mcgowan from Fairview Oct. 24, 1906. Their first child lived one day; the marker in Springville Cemetery reads only "Baby Cherry." Three daughters, Lucille, Opal, and Dorothy, arrived later. The family lived in Marion.

Thomas Cherry died Oct. 10, 1967, and his wife two years later. They are interred at Cedar Memorial in Cedar Rapids. Three of the Cherry Sisters (including Jessie, who died in 1903 at Hot Springs, Ark.) are interred at Murdoch-Linwood Cemetery, Cedar Rapids. The burial place of Ella, Lizzie, and their parents is Oak Shade Cemetery, Marion. Inez and Anna's grave sites are unknown.

White family had 11 boys, no girls

(Story reprinted from August 2016)

In April 1849, Hosea and Elizabeth White moved to Springville from West Point in southeast Iowa. With them were three little boys: Marcus, 6; Julius 2; and Albert, 6 months. In the next 20 years, eight more baby boys arrived. Hosea had 11 sons, but no daughters.

The oldest two were sons of Hosea's first wife, Mary Ann Hudson. She died in Lee County after giving birth to Julius in March 1847. In December of that year, Hosea married Elizabeth "Libby" Green – a stepmother at age 18. Libby's older stepson, Marcus, served in the Civil War; her youngest son, Antrim, was born three years after the war ended.

The shoemaker's trade that Hosea had learned as a youth in Stanstead Plain, Quebec, came in handy. Farming was his main occupation in Brown Township (east of Springville), but he also kept all 11 sons in boots and shoes.

Today, no known descendants of Hosea White live in the Springville area. Once grown, his 11 sons scattered – to western Iowa and to Idaho, Oregon, Texas, and California. The Golden State attracted seven White brothers – five to Sacramento, two to Pasadena.

The group included a doctor, two lawyers, a miner, two hardware dealers, a railroad bridge contractor, and a railroad fireman and mechanic who later became a rancher. One brother owned a creamery in Paton, Iowa (Greene County) until moving to Texas in the early 1900s to farm.

Only one stayed in Iowa all his life. Julius, the second-oldest, farmed near Rolfe (Pocahontas County) and lived to 98. He married Josephine Oxley of Linn County, and their 73rd wedding anniversary was Jan. 7, 1942. It was also Josephine's 91st birthday.

Frank (Benjamin Franklin White) lived only 45 years. After about 20 years in California, he returned to Iowa before his death in June 1900. He is buried in the Springville Cemetery, as is his brother Oscar, who died at 57 in January 1909.

Other family members interred at Springville are Frank and Oscar's sister-in-law, Nellie Stewart White (second wife of brother Ralph); baby Edwin White, son of Ralph and his first wife, Lucinda Fox White; and Hosea and Elizabeth, who died in 1901 and 1919.



Marcus Hudson White, born in 1843, and Julius White, 1847, were sons of Hosea and Mary Ann Hudson White. Hosea and his second wife, Elizabeth Green White, had Albert G., born in 1848; Clinton Lemuel, 1850; Oscar S., 1851; George Eli, 1853; Benjamin Franklin "Frank," 1855; Ralph, 1859; Lincoln, 1862; Charles Green, 1864; and Antrim Lester, 1868. The last

survivor was Antrim, who died 62 years ago, in March 1954.



The Springville City Council met in regular session December 5, 2022.

Pledge of Allegiance was recited.

Mayor Andersen called the meeting to order at 6:00 pm. Council members present: Brad Merritt, Karla Blakely, Jeff Baych, and Cindy Kilburg. Bart Barner was absent. City staff present: Public Works Supervisor Todd Wyman, and City Clerk Dee Wagaman. Pat Hoyt Sr., Ethan Hosek, Treva Davis, Zach Armstrong, Jim Koppenhaver, and Chris Armstrong were also present.

Blakely made a motion to approve the agenda, seconded by Baych. All ayes. Motion carried.

Baych made a motion to approve the following consent agenda items. Approval of November 21, 2022, meeting minutes, and claims, seconded by Kilburg. All ayes. Motion carried.

The following reports were presented: Linn County Sheriff's report, public works report, treasurer's report, and clerk report.

Mayor Andersen reported on the tree lighting. Council had nothing to report.

Mayor invited citizens with input to speak. Ethan Hosek of 606 Broadway St. spoke to council about getting on the agenda for backyard chickens. He has partnered with Kelli Kennon-Lane with Indian Creek Nature Center. They would like to come to a future council meeting to present to the council the reason for allowing backyard chickens. She has helped Marion in their process to allow for backyard chickens. He presented the council with a handout. Zach Armstrong of 2506 Springville Rd. asked the Council if there have been any updates about Wendling using the City's lagoon drive for quarry access. Mayor Andersen informed him that he had a meeting with Cathy Cutler later this week and would inform him after the meeting, but he was mostly going to be talking to her about getting our water system under the overpass. Chris Armstrong was questioning if there were minutes from these meetings that are being held with the Quarry and IDOT. No minutes. He is looking for more transparency. He would like others to be involved in these meetings. Councilmember Baych will try to go to the meeting with the Mayor and IDOT. There being no further public comments, Mayor Andersen moved to business.

Merritt made a motion to move the January 2nd meeting to Tuesday January 3rd, seconded by Blakely. All ayes. Motion carried.

Discussion was held on the current water meters. Our provider is going to cellular, and staff does not agree with cellular. There are too many updates and inconsistencies. They received a quote to just change out the radios with another company so the meters can continue to be used. Staff is getting more bids.

The cemetery mowing contract has expired. Ellison Lawn Care anticipates a 7% increase in his rates. The city did not receive any bids last year and they are good with keeping the contract local. Blakely made a motion to approve Resolution 55-2022, seconded by Baych, RCV: AYES: Kilburg, Baych, Blakely, Merritt. ABSENT: Barner. RESOLUTION 55-2022 adopted.

Council discussed the council code of conduct and meeting rules. Several changes were made. Clerk will bring back the Code of Conduct to the next meeting.

The next regular council meeting will be Monday, December 19, 2022, at 6:00 p.m. at City Hall.

December 5, 2022 There being no further discussion, Kilburg moved to adjourn at 7:24 p.m., seconded by Baych. All ayes. Motion carried.

December 19, 2022 City Council Regular Meeting

The Springville City Council met in regular session December 19, 2022.

Pledge of Allegiance was recited.

Mayor Andersen called the meeting to order at 6:00 pm. Council members present: Brad Merritt, Karla Blakely, Jeff Baych, Cindy Kilburg, and Bart Barner. City staff present: Public Works Supervisor Todd Wyman, and City Clerk Dee Wagaman. Jim Koppenhaver was also present.

Kilburg made a motion to approve the agenda, seconded by Blakely. All ayes. Motion carried.

Baych made a motion to approve the following consent agenda items: Approval of December 5, 2022, meeting minutes, and claims, seconded by Barner. All ayes. Motion carried.

The following reports were presented: Linn County Sheriff's report, library report, public works report, and clerk report.

Mayor invited citizens with input to speak. Jim Koppenhaver of 608 4th Ave asked if there is anything that can be done on the burn out mark in the cemetery. This was done when the concrete was first poured. Wyman will research but does not think there is anything that will remove it without making it a different color. There being no further public comments, Mayor Andersen moved to business.

Blakely made a motion to approve the second reading of Ordinance 9-2022 pertaining to golf carts, seconded by Baych. RCV: AYES: Blakely, Merritt, Kilburg, Barner, Baych. NAYS: None. Baych made a motion to approve Resolution 56-2022, a resolution to approve the FY24 Linn County Sheriff's contract, seconded by Barner, RCV: AYES: Barner, Baych, Kilburg, Blakely, Merritt. NAYS: None. Resolution 56-2022 passed.

Wyman presented the LL Pelling seal chip rates for 2023. Accepting these rates does not lock the City in using LL Pelling but does lock in the rate. Their seal chip rate increased by 30 cents to \$2.70/SY. Their patch increased by \$25/ton to \$285.00/ton. Merritt made a motion to approve Mayor and Wyman to sign the proposal, seconded by Blakely. All ayes, motion carried.

Discussion was held on paying Brown Township \$524.50 for elected officials insurance coverage. Kilburg verified with ICAP insurance that the line item in question only covers Brown Township Trustees and Clerk. Baych made a motion to pay the Brown Township insurance bill less the \$524.50 for elected officials' insurance, seconded by Blakely. All ayes. Motion carried.
