Wow! July is already here. Doesn't it seem like time is just moving quickly? Our lives are still being somewhat controlled by this crazy pandemic. Your council is in process of trying to figure out the re-opening of City Hall. We communicate with other municipalities and the county to keep us all uniformed. Our biggest hurdle is that our office cannot maintain 6' of social distancing between customers. We are working through this and will come up with a plan.

The office has been busy tying down fiscal year 2020. Council approved a 2% increase to the water rate and a 4% increase to the sewer rate. There is also a \$4.25 increase to the sewer debt fee. This is the most important piece to the increase. The funds received from the sewer debt fee are used to pay off the loan for the new lift station and sewer lining. You will see the increase on your September bills. Council has also approved that the sewer debt fee will also increase an additional \$4.25 next year.

July is a very busy training month for the Clerk's office. There may be times we will be working on shortened hours or closed. Everything we are doing in here is to make us more efficient and better able to serve you, our citizens. We appreciate the patience and cooperation you have all shown us during this unprecedented time. We are very much looking forward to when we can see you all face to face.

The City staff wishes you all a Happy Fourth of July. Please be safe and remember fireworks are only allowed from 4:00PM to 11:00PM. Be courteous of your neighbors.

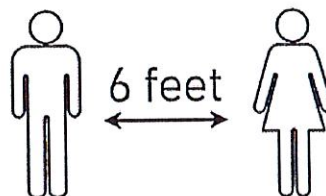


REMINDER:

A STROLL THROUGH THE HIS

Was Julia really 70? Anyway, the party was lovely!

From the Springville New Era, June 22, 1898:

"The seventieth birthday of Mrs. Julia Brown was royally celebrated at her home last Wednesday. The Brown farm is one of the landmarks of the county, and there were few so widely known as Mr. and Mrs. Horace Brown.

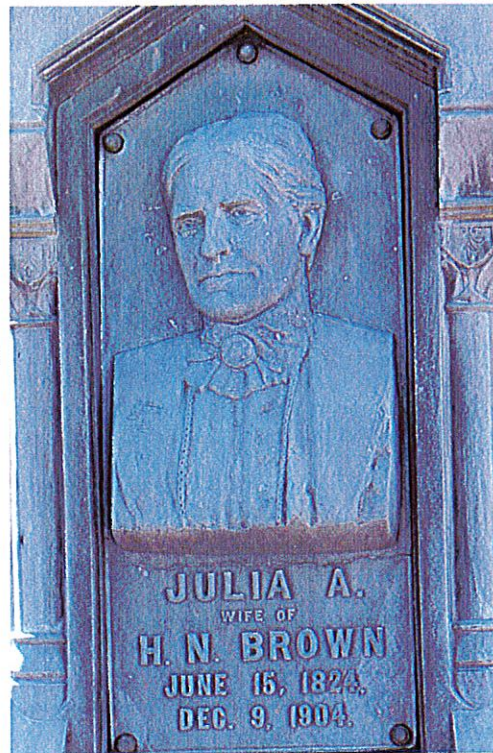
"Since the death of the former (in 1893), Mrs. Brown has continued to live in the old home, which is just as hospitable, with its doors wide open and inviting as ever.

"The event of last Wednesday was a surprise, the hostess having been enticed away during the preparations and everything made ready without her knowledge . . .

"Over fifty persons were present, and the occasion was indeed an enjoyable one. . . . The guests had been requested not to bring presents. The home folk, however, presented Mrs. Brown with a very handsome adjustable chair. The New Era gladly wishes Mrs. Brown many another happy anniversary."

(NOTE: Whether Julia Brown turned 70 in 1898 is questionable. Various censuses indicate birth years for her ranging from 1827 to 1831. The Brown monument in the Springville Cemetery has 1824. Regardless, the 1898 party was great!)

SPRINGVILLE RESIDENTS Jean Schmidt and her brother, Don McShane, are distant relatives of Julia Chapman Brown. Their great-great-grandfather, Nathaniel Chapman, was Julia's brother. Nathaniel's daughter married John Andrew Davis. The Davises were grandparents of the late Clara Davis McShane, Jean and Don's mother.



This bas-relief sculpture of Julia Chapman Brown is on the north face of the Brown monument in the Springville Cemetery. The 1886 monument commemorates Julia's father-in-law, Revolutionary War Veteran Nathan Brown.

Bill Herren locates Fannie Abbott

In March 1904, Fannie Branch Abbott sold her house at 405 Liberty Ave. in Springville. Where she went then was a mystery until recently. Now Bill Herren of the Springville Area Historical Society has traced Fannie and two relatives to Oregon.

Fannie and her granddaughter, Pearl Willard Stewart, are buried in Idlewilde Cemetery, Hood River, Ore. Fannie, 75, died in 1907. The cause of Pearl's death at the early age of 22, in May 1909, is unknown.

Pearl's mother, Ettie Abbott Sigwalt Willard, married her third husband, Edward Iverson, about 1902. In 1910 they were living in Glenn County, Calif. By 1920, they were in Crook County, Ore. Ettie, 66, died Feb. 27, 1926. Her grave is in Pilgrims Rest Cemetery, Powell Butte, Ore.

1904 'Ladies of the Club' embroidered at Paralta

Paralta Embroidery Club was founded May 5, 1904, at the Stevens home in Paralta, a hamlet two miles south of Springville. Embroidering was the main activity at meetings, which were held in members' homes. The hostess always served refreshments.

The first president was **Emma Francelia Aldrich Stevens**, 57. Born in Worcester, Mass., she was a Cornell College graduate. Her husband, Pennsylvania native Delos D. Stevens, held degrees in both medicine and law. The Stevenses were childless.

Ida May Bolton Hudson, 32, and her husband Charles were parents of Beulah, 9, and Gladys, 7. (Ida's parents, Abram Bolton and Susanna Kearns Stewart Bolton, had registered the plat of Paralta in 1880.) The Hudsons divorced in 1909.

Caroline "Callie" Hempy Stearns, 48, was the first vice president. She and her husband, farmer Earl Stearns, had two grown sons, Wilbur and Dana. In 1903 the Stearnses had taken in an orphan girl, also a charter member of Paralta Embroidery Club.

She was **Josephine "Josie" Lacock**, 14. Her parents, Albert and Albertine Lacock of Paralta, had died of tuberculosis. At 17, Josie married LeRoy L. Kindig, an employee of the Chicago, Milwaukee & Pacific Railroad at Marion.

Abigail Jane Gage Yule, 42, was born near Fairview in Jones County. She was called Abbie. Married at 28, she was about seven years older than her husband, farmer Fred W. Yule. They later moved back to Jones County, and Abbie was a church organist.

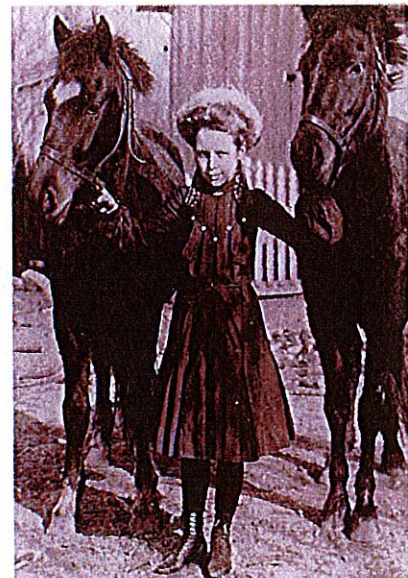
The sixth charter member, identified in club minutes only as "**Mrs. Armstrong**," might have been Nettie Emma Kimball Armstrong, wife of William H. Armstrong. Club minutes identify the seventh as "**Mrs. Caldwell**." Her first name was possibly Cora or Elizabeth.

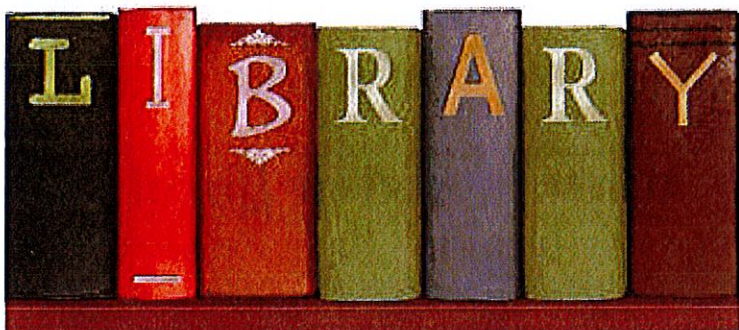
Paralta Embroidery Club is now 116 years old and has 13 members. Embroidering at meetings ceased long ago. The club met continuously until this spring, when Covid-19 restrictions intervened. On June 15, four members met "through the window" at Bickford care center in Marion to celebrate the 92nd birthday of **Pat Rose**.

Opal Stearns was the granddaughter of Callie Hempy Stearns, a charter member of Paralta Embroidery Club. Born in 1906, Opal was a first cousin of Ruth Wurster, a current member of the club. Opal's married name was Beatty.





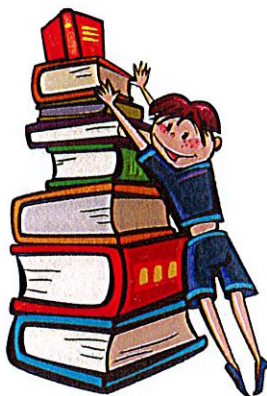

City Council Regular Meeting

June 1, 2020

The Springville City Council met in regular session June 1, 2020. In order to help stop the spread of the COVID-19 virus, this meeting of the Springville City Council was held electronically. Chapter 21.8 of the Iowa Code does permit an electronic meeting where all members participate remotely when an in-person meeting is impossible or impractical, which is certainly true during this crisis. On March 19, 2020, Governor Reynolds issued a Proclamation of Disaster Emergency, which included a suspension of Iowa laws that would prevent the use of electronic meetings or the limitation on the number of people present at an in-person meeting site. The agenda had this message posted more than 24 hours in advance to give instructions on how others could participate in the meeting: *Due to the COVID-19 crisis, the City of Springville will be holding this City Council meeting electronically via a conference call. If you would like to participate in the meeting, please call (425)-436-6369 and enter this access code: 331423. Only City staff are allowed in City hall.*

Mayor Pro tem Grimley called the meeting to order at 6:00 p.m. Council members present: Brad Merritt, Lyle Andersen, Jeff Grimley, Bart Barner, and Karla Blakely. Mayor Shebetka absent. City staff present: Public Works Director Todd Wyman, Asst. Fire Chief Jeremy Ketelsen, and City Clerk/Treasurer Dee Wagaman. Guests present: Jeff Baych, Christian Andrews, Ashley Detterman, and Ashley Luzinski.

Andersen made a motion to approve the agenda, second from Blakely. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of May 18, 2020 minutes and approval of bills, second from Blakely. All ayes. Motion carried.

Mayor Pro tem Grimley invited citizens with input to speak. Christian Andrews introduced himself to council. Andrews is on the ballot for the Iowa House. There being no comments from citizens, Mayor Pro tem Grimley moved to business.

Jeff Baych has requested to put an underground fence on City property that abuts his residence. Would like council to consider selling, or providing an easement. Lengthy discussion held about the liability of allowing a homeowner to put a fence on City property. Council against selling. Council told Baych that he could drive on the property or allow his dog to run on the property. No action taken.

Resident at 605 4th Ave has requested that his sewer portion of his water bill be waived. He filled his pool and does not feel he should have to pay for the sewer charge. Council discussed the reasons that this policy of not waiving such fees was put into place. There is the option to any homeowner to install a second meter that would be used solely for irrigation. Resident will no longer allow the City to test his water annually. Wyman to find a new location and set up with the IDNR. No action taken.

Lengthy discussion about allowing chickens in City limits. Luzinski & Detterman presented the advantages for having chickens. Council followed up with some citizens and other communities that allow chickens. Both reports have come back unfavorably. Will look into polling a larger group of citizens.

Governor Reynolds has allowed playgrounds to be open as of June 1. Council has agreed to open the City playgrounds immediately letting the public know they are not monitored or cleaned.

Wyman discussed the box culvert on 1st Ave. There is visible damage on the underneath of the culvert. Council requested estimates from our engineers to look at it to give us guidance for a repair. Eastern Iowa is willing to work with us for a repair.

Wagaman explained the lack of communication and payment from

one resident in town. The City has not received payment since February. Council agreed to turn the water off.

Linn County Sheriff's report presented via email. There were 21 calls for service between 5/18/2020-6/1/2020:

Wyman presented public works report.

Ketelsen presented report for fire department.

Wagaman presented clerk/treasurer report.

Andersen informed the council of the Legion wanting to open a beer garden. Looking for ways to generate more revenue.

The next regular council meeting will be June 15, 2020 at 6:00 p.m. at City Hall.

There being no further discussion, Andersen moved to adjourn at 7:16 p.m., second from Blakely. All ayes. Motion carried.

Barner made a motion to approve the following consent agenda items: Approval of June 1, 2020 minutes, approval of bills, and approval of Legion's liquor license, second from Andersen. All ayes. Motion carried.

Mayor Pro tem Grimley invited citizens with input to speak. There being no comments from citizens, Mayor Pro tem Grimley moved to business.

Andersen presented Resolution 168-2020, a resolution to approve FY21 wages, second from Merritt. RCV: AYES: Barner, Blakely, Merritt, Andersen, and Grimley. NAYS: None. **RESOLUTION 168-2020 adopted.**

Barner presented Resolution 169-2020, a resolution to approve a \$4,820 transfer to the Library Savings account from General Fund, second from Andersen. RCV: AYES: Barner, Blakely, Andersen, Merritt, and Grimley. NAYS: None. **RESOLUTION 169-2020 adopted.**

Rich Blakely updated council that the Quarry Run is still waiting for approval from the Quarry, but at this time, they are planning on having the Quarry Run. Adjustments will be made to make it safe. The Springville Tractor Puller's Association will make a decision on the tractor pull during their July 7 meeting. As of right now, the

event is still on. Linn County Public Health has strongly suggested if the City continues with the kids' Fun Zone that all workers wear masks, the inflatables need to shut down every 20-30 minutes for cleaning. The lines for the games need spaces marked for 6' social distancing and they will need cleaned after each participant. With the current restrictions and the fact that school will be starting very soon after this event, Andersen made a motion to suspend the Fun Day Parade and the Kids' Game Zone in the park for 2020 due to Covid-19, second from Merritt. All ayes. Motion carried.

Andersen presented information to the council regarding the Linn County Emergency Management Agency to provide support for the outdoor warning sirens. He is asking Council to approve Resolution 170-2020 which shows the County that the City of Springville is in support of the County taking control and maintaining our outdoor sirens. Blakely made a motion to approve Resolution 170-2020, second from Barner. RCV: AYES: Barner, Blakely, Andersen, Merritt, and Grimley. NAYS: None. **RESOLUTION 170-2020 adopted.**

Discussion on City Code 165.22 Subsection 2 pertaining to fencing requirements for swimming pools. Several pools have recently been put up in yards with no fences. Council discussed the pros and cons to eliminating the requirement for fences. It is very hard to enforce the "bubble style" pools that are put up in a weekend and taken down just as quickly. Barner made a motion to approve Resolution 171-2020, a resolution to set a public hearing (July 6 @ 6 p.m.) to amend City Code chapter 165.22 Subsection 2, second from Andersen. RCV: AYES: Barner, Blakely, Merritt, Andersen, and Grimley. NAYS: None. **RESOLUTION 171-2020 adopted.**

Wagaman discussed the FY19 Audit report with Council. She presented a report of all the findings and recommendations. She outlined what the Clerk's office was doing to correct some of the findings and how they were accommodating some of the recommendations.

Linn County Sheriff's report presented via email. There were 18 calls for service between 6/1/2020-6/15/2020.

Wyman presented public works report.

Ketelsen presented report for fire department.

Davis presented Phase 1 of the library reopening.

Wagaman presented clerk report.

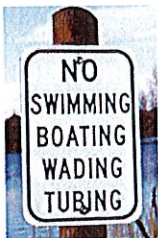
There will be a special meeting on June 29, 2020 at 6:00 p.m. at City Hall to approve fiscal year 2020 bills.

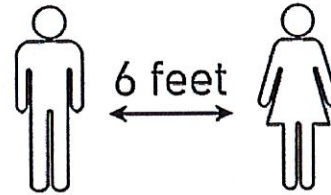
