FY 2023-2027 Iowa Transportation Improvement Program Approved by the Iowa Transportation Commission.



The commission has approved the Hwy 151 overpass in the 5-year plan. In this project they plan to build a new bridge over the existing highway. Final plans are not done at this time, but the project will be funded. This is great news for Springville and our residents.

WATER/SEWER RATE INCREASE



A Public Hearing was held Monday, June 20, 2022 at 6:27 p.m. to amend chapters 92 & 99 to increase water and sewer rates. The council is proposing to raise the water base rate charge 3%, adding a water debt service fee of \$3.30/mo., increasing the sewer debt fee by \$1.50/month, but decreasing the sewer base rate by \$1.50. Each resident who uses both water and sewer will see a \$3.76 increase in their bills. Second reading of this ordinance will

be during the July 5, 2022 City Council Meeting.

A STROLL THROUGH THE HIS

Clara Bee's store: A brief chapter in Springville history

Byron M. Hopper was a long-time Springville merchant. He first owned a drugstore on the South Side. About 1898, he moved to the North Side, sold his drug stock, and began selling groceries. In 1903, he moved into the new brick block on the west side of Broadway.

After 47 years in Springville, Hopper died May 3, 1924. The next month, his former store became Clara Bee's. This store sold "groceries, dry goods and general merchandise of all kinds," according to the introductory ad in the Springville New Era June 12, 1924.

Owner Clara Tracy had moved to Martelle in May 1918 with her third husband, James E. Tracy; her teenaged daughter (by first marriage), Helen Petersen; and her 3-year-old son, called Robert Fisk. Robert's father was a Holbert, Clara's second husband a Fisk. Robert was born out of wedlock. Clara and James' only child, James Tracy Jr., was born in March 1919 when Clara was almost 41.

James Tracy Sr., a native of Strawberry Point, was the Milwaukee Road depot agent in Martelle. Later he became cashier at the local bank. Clara opened a grocery store in Martelle about December 1921, and also had a "store on wheels" that served rural residents.

A 1920 graduate of Martelle High School, Helen started nurse's training in Rockford, Ill. However, she returned to Martelle in fall 1921. She was not quite 22 when serious health problems (nature unknown) led her to take a lethal dose of strychnine in May 1924. Her funeral was at Martelle Methodist Church, with burial in Rochelle, Ill., her mother's home town.

Soon after Helen's death, James took over management of Clara Bee's in Martelle when his wife started the Springville store. Despite major publicity in the New Era, the Springville Clara Bee's lasted only slightly over two years. On Aug. 19, 1926, a large ad announced "Clara Bee is Leaving Springville and Everything Goes in One Grand, Stupendous Slaughter Sale."

Clara, James and two sons then moved to Southern California. The 1930 census found them in La Habra, Orange County. James Sr.'s occupation was "merchant, grocery." He was 53; Clara 51; Robert Tracy (no longer called Fisk), 14; and James Tracy Jr., 11. There was also a roomer, Roy Woodworth, 23, son of James "Frank" and Minga "Maggie" Woodworth of Springville.

About 1931, Clara's granddaughter Jeanne, 13, came from Iowa to join the Tracy household. Jeanne was born to Mildred Petersen (Clara's daughter) in 1918 when Mildred was single. However, the child was told that Clara and James Tracy were her parents.

By 1935, the Tracys had moved from La Habra to Brea, also in Orange County. The 1940 census showed another of Clara's daughters, Irene Petersen Armstrong, in the household. Irene, 40, had married Howard T. Armstrong in 1914 in Iowa. Apparently she was visiting her mother when the census was taken.

After 23 years of marriage to Clara, James Tracy Sr. died at 64 in July 1941. Clara survived him over 24 years. As a widow, she moved to

Whittier, Los Angeles County, Calif. She died there March 12, 1966, at age 87. Clara and James are interred at Loma Vista Memorial Park, Fullerton, Orange County, Calif.

CLARA ALBERY BROWN was born May 22, 1878, in Rochelle, Ill. She was married three times – at ages 18, 32 and 40. In her first marriage to Peter Christian Angelbert Petersen she had three daughters. Her second marriage to Andrew Fisk was childless. She had a son out of wedlock (Holbert) at age 37, and a son in her third marriage to James Tracy.


FOR SEVERAL YEARS before her third marriage, Clara Tracy worked as a secretary to A. B. Holbert, an internationally known importer, breeder, and seller of registered horses. His business was located near Greeley in Delaware County, Iowa. In November 1914, A. B. Holbert was elected to the 36th Iowa General Assembly. A. B.'s son, Fred Holbert, was the father of Clara's son Robert.

LIBRARY DIRECTOR'S RECAP

A new fiscal year is here, and it always makes me reflect back on the previous year.

The past year saw our library being able to open for regular hours again. Such a good feeling!

Several projects for our patrons were completed. Automatic front entrance doors were installed. Thank you to community donors who helped see this project come to fruition.

The library was able to obtain an ARPA Grant up to \$5,000.00 through the State Library. The grant enabled us to buy a new door counter, a receipt printer for our self check out station and a solar charging bench. Patrons can use the bench to charge their phones and other devices when they are out walking. An additional solar unit will be installed in the playground area at Cox Lake.

STEAM kits were a popular addition to our collection. We'll be adding to them.

Circulation continues to grow and patronage numbers are up, all of which makes for a a busy library. This is such a pleasure after the constrictions we experienced during the pandemic.

We look forward to the opportunities of FY2022-2023. Let's make it happen!

June 6, 2022.

The Springville City Council met in regular session June 6, 2022.

Pledge of allegiance was recited.

Mayor pro tem Barner called the meeting to order at 6:00 pm. Council members present: Karla Blakely, Bart Barner, Brad Merritt, Jeff Baych, and Cindy Kilburg. Mayor Andersen was absent. City staff present: Public Works Director Todd Wyman and City Clerk Dee Wagaman. Treva Davis was also present.

Kilburg made a motion to approve the agenda, seconded by Baych. All ayes. Motion carried.

Blakely made a motion to approve the following consent agenda items: Approval of May 16, 2022, meeting minutes, and claims, seconded by Merritt. All ayes. Motion carried.

Officer Tindal presented Linn County Sheriff's report.

Library report included in packet.

Public Works report included in packet. Wyman also gave a report on the Fishing Derby. There were 18 kids registered, 22 fish and 2 turtles caught. Jeff Menster, Rick Evans, and Brandon Barker came out to help the kids learn how to fish.

Treasurer's report included in packet.

Clerk report included in packet.

Mayor pro tem invited citizens with input to speak. Davis stated name and address. She is very appreciative of Todd and Brandon getting a bench put on the east end of the Cox Pond Trail. She said that they also went above and beyond working with the library board/staff to get their new solar bench installed. There being no further public comments, Mayor pro tem Barner moved to business.

Merritt made a motion to approve rescheduling the July 4th meeting to July 5th, seconded by Blakely. All ayes. Motion carried.

Baych made a motion to approve the flag disposal ceremony and the burning of the flags on June 11th at Cox Pond, seconded by Kilburg. All ayes. Motion carried.

Blakely made a motion to appoint Daryl Pearson to the Planning & Zoning Commission for a 5-year term, seconded by Baych. All ayes. Motion carried.

Discussion was held on the plans, specs, and cost estimate for Bid Package #2. Council would prefer not to rush the deadline so to move the completion date to June of 2023. Baych made a motion to approve Resolution 27-2022, a resolution to approve bid package #2, seconded by Blakely. RCV: AYES: Barner, Baych, Merritt, Kilburg, Blakely. NAYS: None. **RESOLUTION 27-2022 adopted.**

Discussion was held on where council would like to take funding from. There will be some water, sewer and LOST funds added to the project. There will be the potential to use money in excess from Derecho. They will wait to make final decisions when they get a report back from the fundraising committee.

Discussion was held on water/sewer rates for FY23. Council will be looking at an increase of \$3.76/resident per month. This will include a new Water Debt Fee of \$3.30, an increase in the water base rate of 3% (\$0.46), an increase in the Sewer Debt Fee of \$1.50, but a decrease in the sewer base rate of \$1.50. Blakely made a motion to approve Resolution 28-2022, to set a public hearing on Monday, June 20, 2022, at 6PM, seconded by Kilburg. RCV: AYES: Barner, Merritt, Blakely, Baych, Kilburg. NAYS: None. **RESOLUTION 28-2022 adopted.**

The next regular council meeting will be June 20, 2022, at 6:00 p.m. at City Hall.

There being no further discussion, Blakely moved to adjourn at 7:40 p.m.,* seconded by Kilburg. All ayes. Motion carried.

City Council Special Meeting

June 20, 2022

The Springville City Council met in regular session June 20, 2022.

Pledge of allegiance was recited.

Mayor Andersen called the meeting to order at 6:00 pm. Council members present: Bart Barner, Brad Merritt, Jeff Baych, and Cindy Kilburg. Karla Blakely was absent. City staff present: Public Works Director Todd Wyman and City Clerk Dee Wagaman. Melissa Waldron, Treva Davis, and Jim Koppenhaver were also present.

Bart made a motion to approve the agenda, seconded by Kilburg. All ayes. Motion carried.

Baych made a motion to approve the following consent agenda items: Approval of June 6, 2022, meeting minutes, claims, and American Legion liquor license, seconded by Merritt. All ayes. Motion carried.

Officer Tindal presented Linn County Sheriff's report.

Library minutes included in packet.

Public Works presented report. Wyman also gave a report on his visit with the IDNR. They will be back in July to do a sampling of our fish population. They also talked about possibly needing or recommending dredging the pond. The IDNR also provided signage that Wyman will order for our pond. Residents will be allowed to keep certain fish.

Clerk report included in packet.

Mayor had nothing to report.

Councilman Baych reported that there was a lot of misinformation going around Facebook about the splashpad money. He wanted to make sure that the community knew that the money has been in CDs and savings accounts. It is now being used towards the Emmons Park project. Wagaman added that this campaign was so long ago and most of the funds raised were by small fundraisers. It would be impossible to account for all the small donors. The American Legion was one of the only large donors and they are comfortable with the monies being used for Emmons Park. The splash pad campaign only had about \$36,000 in funds.

Councilman Barner reported that the Parks Board was getting ramped up for Fun Days.

Mayor invited citizens with input to speak. There being no public comments, Mayor Andersen moved to business.

Security State Bank was not here to discuss the HWY 151 overpass. Andersen reported that Tyson Jacobi, Barner, Wagaman, and Andersen went to Coralville on Tuesday June 14, 2022, to show the commission support for the project and expressed the City's desire for this project to get funded. The office was notified on Wednesday that the project was approved to be funded in the 5-year plan.

Mayor Andersen presented the nuisance hearing for 607 1st Ave. Waldron spoke on her own behalf. She currently has 4 ducks and 6 chickens. She would like to be allowed to keep 6 chickens. They are kept in a coop. She is legally disabled, and the animals bring her comfort. She grew up on a farm, so caring for them is very natural for her. Council would like to see her documentation supporting her claim. She will bring it to City Hall. Council will also research and discuss with the City attorney. This will be back on the July 5th council meeting.

Andersen opened the public hearing to amend chapters 92 & 99 at 6:27 pm. No one spoke in favor or against the proposed rate changes. No communication came into the office. Barner made a motion to close the public hear-

ing at 6:30 pm, seconded by Kilburg, RCV: AYES: Kilburg, Baych, Barner, Merritt. ABSENT: Blakely. NAYS: None. Motion carried. Council understands that they must raise the rates to keep up with future projects and current costs. They regret the affects that it may have on the residents. They understand that the water and sewer are businesses that must support themselves. They are discussing to raise the water base rate charge 3%, adding a water debt service fee of \$3.30/mo, increasing the sewer debt fee by \$1.50/month, but decreasing the sewer base rate by \$1.50. Each resident who uses both water and sewer will see a \$3.76 increase in their bills.

Barner made a motion to approve the first reading of Ordinance 1-2022 to amend the water and sewer rates, seconded by Baych. RCV: AYES: Merritt, Barner, Kilburg, Baych. ABSENT: Blakely. NAYS: None. First reading of Ordinance 1-2022 passed. Council will do second reading during the July 5, 2022, meeting.

Barner made a motion to approve Resolution 29-2022 to set a public hearing for Emmons Park Bid Package #2, seconded by Kilburg. RCV: AYES: Baych, Barner, Kilburg, Merritt. ABSENT: Blakely. NAYS: None. RESOLUTION 29-2022 adopted.

Mayor Andersen presented moving to one meeting a month. He feels that our meetings are efficient and could be handled one time a month. All the small towns and some of the larger towns only have 1 meeting a month. This would also eliminate the clerk's office from creating packets and paying bills twice a month. Council likes getting together twice a month. They like the communication it creates and feels that only once a month, they might be out of the loop. They also discussed having one of the meetings be a workshop and the second meeting be a business meeting. They will continue to discuss this topic.

Mayor Andersen appointed Marla Carnahan as recommended by the Library Board to the Library Board. Merritt made a motion to approve Carnahan's appointment, seconded by Baych. All ayes. Motion carried.

Mayor Andersen has been figuring out how he wants to handle wages/ raises. He started at ground zero with all reviews and won't have an annual review until December. He would also like to create a wage scale with steps so that council will be making clear decisions where an employee falls in the steps. He thinks wages have just been done with very little thought behind them. He would like to table this topic to give him a bit more time to come up with some suggestions.

There being no further discussion, Barner moved to adjourn at 6:49 p.m., seconded by Kilburg. All ayes. Motion carried.
