



- Appliances limited to (2) per residential household or business (air conditioners and water heaters are considered appliances).
- Electronics accepted: copy & fax machines, cd players, VCRs, TVs, stereos, battery backups, cell phones, computer equipment, computer cords, etc.
- If you need assistance with your items, please call City Hall at 319-854-6428.

\*\*Items not accepted: lead acid batteries, tires, railroad ties, radioactive materials, untreated medical waste, Styrofoam, any recyclable materials, pressurized tanks, and material usually deposited in garbage bags, raw construction materials (shingles, wood, concrete, re-rod, etc.), burn barrels and ash, large commercial appliances (walk -in freezers, commercial stoves, etc.) and hazardous waste items. # A STROLL THROUGH THE HIS

# A look at varied bridal attire 'back in the day'

What did the bride wear? Following is a sample of gown descriptions from 1882 to 1926. The material in quotation marks was provided by wedding reports in the Springville New Era.

1882, Christmas Day – Clara Belle Burger, 20, and Charles "Fred" Butler were married at the home of the bride's parents, Abraham and Margaret Burger. "The bride was attired in a silk dress of the color known as 'dregs of wine'" (probably dark burgundy).

1904, January 20 – Jennie Cool and Hallie Reed were both of Viola. Jennie was "becomingly attired in a gown of lavender Lansdown silk, trimmed with cream-colored silk, medallions, and applique."

About 1909, June 8 – Caroline Dunlap, 23, of Springville and the Rev. Paul E. Ratsch of Portland, Ore., had met as students at Coe College. For the wedding, "the bride wore a gown made of just, a beautiful thin creamy white cloth woven in the Philippines." Caroline's parents were Mr. and Mrs. Alexander T. Dunlap.

1910, January 26 – Roxsey Ethel Bell, 22, was dressed in "white brocaded satin over soft white satin with pearl and crystal trimmings" for her marriage to Charles Jay McShane. The home of the bride's parents, William "Billy" and Jennie Bell (on the site of today's Presbyterian church parking lot) was the setting.

1912, February – In a double wedding, **Ada Mae Hoag**, 24, married **Samuel Bair**, and her sister **Vernie Case Hoag**, 22, became the bride of **Clelland Port**. "The brides were attired alike in beautiful gowns of cream Lansdown trimmed with silk chenille and cream net yoke trimmed with silver." Their parents were Nathan and Margaret Price Hoag.

1926, November 13 – Irvine Leah Romans, 22, and Charles Vlasak were married at the home of the bride's parents, Joe

and Rachel Calvert Romans (the former 1865 brick school on High Avenue). Irvine "looked very becoming in a white satin dress with rhinestone trimmings and a veil held by orange blossoms."

1927, July – The bride's gown was not described, but the location was unusual. **Leona Irvene Campbell**, 21, of Springville and **William C. Dunlap** of Marion exchanged vows on the launch Bobolink "on the calm waters of Clear Lake." (Did the wedding guests wish them smooth sailing?)

# TORY OF SPRINGVILLE, IOWA



The landscape on High Avenue has been altered forever. On the afternoon of May 6, 2021, a landmark which had stood for over a century and a half was demolished. The two-story brick building had been constructed as an elementary school in 1865, but served that purpose for only 17 of its 156 years. ## Teachers, pupils at 1865 brick school remembered

The 1865 brick building on Springville's High Avenue is gone, 156 years after it was built at a cost of \$1,200. For 17 years, Grades 1 through 8 were educated there. For the next 132 years, people lived in it. During its last seven years, the building stood empty. It was razed May 6, 2021.

Where the bricks were produced, and who built the school, are unknown. However, we have the names of two teachers and three pupils – among many others lost in the mists of time.

Zarah V. Elsberry, born in 1833 in Indiana, moved to Springville in 1855. He served three years in the Civil War, was discharged in July 1865, and began teaching at the new school. For 16 terms Elsberry taught there and at area country schools. The school year consisted of fall, winter and spring terms. Teachers didn't always stay for all three terms.

Corwin D. Stickney, an Ohio native, moved to the Crabapple area west of Springville in 1865 with his uncle and aunt, Charles and Fannie Abbott. When he was 20, Stickney taught at the brick school, apparently just in 1868-69. He then moved to Center Point, but returned to Springville and owned a hardware store and tin shop from 1872 to 1885.


The Springville New Era interviewed Stickney in May 1928, sixty years after he had taught here. At that time, he lived in Marion. He named three of his pupils at the brick school:

Leonard "Len" Christman, born in 1856 near Dubuque, moved to Springville at age 7 with his parents and two sisters. (Four more siblings were born here.) As an adult, Len took over his father John's general store on Broadway and converted it to a hardware store.

Springville native **Charles "Fred" Butler**, born in 1857, was the grandson of Col. Isaac Butler, a Springville pioneer in 1840. Fred's father, Joseph Butler, founded the Exchange Bank in 1878. When Joseph died in 1898, Fred succeeded him as president.

**Daniel W. Hampton**, born at Springville in 1858, was the oldest child of Oliver L. and Hannah Gregg Hampton, Quakers from Ohio. Four of their seven children died in infancy or childhood. Dan and two brothers, Dilwin and Wilbur, lived into their 90s.

Pledge of allegiance was recited.

Mayor Shebetka was absent. Mayor Pro tem Grimley called the meeting to order at 6:00 p.m. Council members present: Bart Barner, Lyle Andersen, and Karla Blakely. Brad Merritt was absent. City staff present: Public Works Director Todd Wyman and City Clerk Dee Wagaman. Several guests present. Andersen made a motion to approve the agenda, second from Blakely. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of April 19, 2021 minutes and approval of bills, second from Blakely. All ayes. Motion carried.

Deputy Tindal presented sheriff's report from 4/19/21-5/3/21. There were 30 calls for service. Parks presented written report. No other reports presented.

Mayor Pro tem Grimley invited citizens with input to speak. There being no comments, Mayor Pro tem Grimley moved to business.

Mayor Pro tem Grimley opened the public hearing to amend Chapter 74 of the Springville Code pertaining to golf carts at 6:03 p.m. Jack Clothier spoke against the requirement for seat belts. He explained that his golf cart is very old and does not think he could even equip his cart. He also does not want to be strapped into his cart. Andy Hoge also spoke against the seat belt requirement. He feels that most residents are following the rules and he would like to see council come down harder on those not obeying the rules. Jeff Adair also called into the office and voiced his opinion against the seat belt regulations. Andersen made a motion to close the public hearing at 6:09 p.m., second from Barner. All ayes. Motion carried. Council continued to discuss the seatbelt requirement. Andersen would still like to see this added for additional safety especially for the kids who are riding on the carts. Barner can see requiring them for kids but would like to follow the public opinion. Barner made a motion to approve the first reading of Ordinance 17-2021 with the requirement for seatbelts removed, second from Andersen. RCV: Ayes: Barner, Blakely, Andersen, Grimley. Nays: None, Absent: Merritt.

Mayor Pro tem Grimley opened the public hearing to amend Chapter 75 of the Springville Code pertaining to ATVS, UTVs, and snowmobiles at 6:21 p.m. Wyman had questions about the proposed code. Andersen made a motion to close the public hearing at 6:28 p.m., second from Barner. Council discussed removing Chapter 75.05 (1)(M) and Chapter 75.05 (1)(N) pertaining to guns. Andersen made a motion to approve the first reading of Ordinance 18-2021 with Chapter 75.05 subsection 1(M) and (N) removed pertaining to guns, second from Blakely. RCV: AYES: Barner, Blakely, Andersen, Grimley. NAYS: None. ABSENT: Merritt.

Chapter 160 of the Springville Code needs to be updated to stay current with the floodplain maps that are effective July 20, 2021. Andersen made a motion to approve Resolution 20-2021 to set a public hearing for May 17 at 6 p.m. to amend Chapter 160 pertaining to floodplain management, second from Blakely. RCV: AYES: Barner, Blakely, Andersen, Grimley. NAY: None. ABSENT: Merritt. RESOLUTION 20-2021 adopted.

Mayor Shebetka moved to business. Hocking gave the council an update of ty plan. He also shared the vision and motion to share the cost of the new fit the school, second from Barner. All a

Andersen made a motion to approve tax abatement application for 705 Wild Pine Ct., second from Barner. All ayes. Motion carried.

Andersen made a motion to approve tax abatement application for 711 Heather Lane, second from Blakely. All ayes. Motion carried.

Wyman presented a current 28E agreement with the Linn County Secondary Roads for road maintenance. He recommended that council approved this 28E agreement. Andersen made a motion to approve Resolution 21-2021 to approve the current 28E agreement with Linn County Secondary Roads, second from Barner. RCV: Ayes: Barner, Blakely, Andersen, Grimley. NAYS: None. ABSENT: Merritt. RESOLUTION 21-2021 adopted.

Discussion held regarding banning the use of consumer fireworks. Andersen made a motion to approve Resolution 22-2021 to set a public hearing to amend Chapter 41 of the Springville Code on May 17 at 6 p.m., second from Barner.

RCV: AYES: Barner, Blakely, Andersen, Grimley. NAYS: None. ABSENT: Merritt. RESOLUTION 22-2021 adopted.

Andersen and Wyman have been working on securing bids for a new track it er. They received 5 bids, one was incomplete, one could not be delivered un late fall. 2 of the bids had one on hand.
