### From the Past - Historical Feature Submitted Feb. 18, 2015 - Karen Taylor

**Springville Historic Anniversary** 

On Monday, March 24, 1856, the plat of Springville was "filed for record . . . and duly recorded" by N. M. Day, recorder of Linn County, Iowa. Aaron P. Risley, acting justice of the peace, certified that "Moses P. Winans and Susan Winans, J. S. Butler and Mariah Butler, Hosea White and Elizabeth White, and J. P. Hoffman, to me personally known" were owners of the plat on which the town was located.

Two days earlier, Samuel W. Durham of Marion had made the survey. The legal description was "the west

half of the southwest quarter of Section 28 and the east half of the southeast quarter of Section 29 in Township 84 N, Range 5 W, 5<sup>th</sup> P.M., Linn Co., Iowa." It was entirely south of the creek; Mill Street (still its name today) was the northernmost thoroughfare.

The erroneous claim that Springville's original name was Brown might have resulted from a misreading of the 1911 Linn County History, which states, "In 1842 the first post office was established in the township known as Brown." The next sentence is clear: "It was the third post office in (Linn) county and was known as Springville." The first postmaster was Isaac Butler.

Following are biographical sketches of the pioneers who turned an early settlement called Springville into a town of the same name.

Born in Ohio, Joseph Samuel Butler was the son of Isaac and first wife, Clarissa Sargent Butler. Joseph came to Springville in 1840 at age 18 and lived here the rest of his life, except four years in Anamosa. He married Mariah (also spelled Maria) L. Reneau in 1854. They had three sons, lost one in infancy and another at 19. Joseph farmed south of town, later going into the grain, stock and dressed hog trade, followed by the mortgage and loan business. In 1878, he founded the Exchange Bank. He died in Springville Dec. 31, 1898, at 77. Butler Park is named for him.

Hosea White Jr. was a descendant of William White, who arrived on the Mayflower. A native of Stanstead, Quebec (near the Vermont border), was trained as a shoemaker. He married Mary Hudson in 1841 in Eaton, Preble County, Ohio. In 1842 they moved to Lee County, Iowa,

where Mary died, leaving two little sons. Hosea then married Elizabeth Green, and came to Springville in April 1849. They had nine sons. Hosea farmed two miles east of town until 1880, when he retired and moved to 602 First Ave. (the house still stands). At age 81, he died there Jan. 23, 1901.



Moses Pryor Winans a native of Miami County, Ohio, where he married Susan Simmons in 1828. They had five sons and four daughters. In 1853, the Winans family and Susan's mother moved to Springville. Moses was postmaster from July 1854 to November 1856. Between 1855 and 1863, he and his son Hiram operated a steam sawmill, first in Brown Township and then in Linn Township. All five of the Winans sons fought for the Union in the Civil War. Moses died in Springville Aug. 23, 1871, at 63. His widow moved to Santa Ana, Calif., and died there in 1900.

John P. Hoffman was born in Milton, Union County, Pa. As a young man, he taught school in Pennsylvania and Wisconsin. In 1849, he went to California and mined gold in Sonora, Weaverville, and Placerville. Returning to the Midwest via Panama in 1851, John opened a store first at Lena, in northern Illinois, and one in 1855 in Springville. In 1856 he married a school teacher, Jane Bertha Kirkwood, and in 1860 they moved to California. Of their seven daughters; one died in infancy. A rancher and businessman, John died Feb. 6, 1903, at Ukiah, Mendocino County, Calif. He was 72.

### J. S. Butler injured in Cleveland

For 21 of his 78 years, Joseph S. Butler walked with crutches, due to a serious accident in his native state of Ohio. It happened Aug. 29, 1877, in Cleveland, where he was attending a Masonic Knights Templar encampment. As he tried to climb between cars of a stopped

train blocking the sidewalk, the train moved. Butler's lower left leg and ankle were crushed. After immediate medical attention, he returned to Iowa, where his leg was amputated below the knee Sept. 12, 1877. The record is silent on who performed the surgery; possibly it was Springville's Dr. John S. Love. Butler was then confined to his home for eight months while he recuperated.

 In the U.S., between \$8-900 million in revenue is lost to businesses every year on Friday the 13ths as people are afraid to travel, shop, or even go to work.
Months that start with Sunday will have a Friday the 13th.

**3.** Every year has at least one Friday the 13th, but no more than three.

4. Fridays are the day most likely to be the 13th.

**5.** Although the number 13 and Fridays were considered unlucky independently for centuries, the origins of Friday 13th are unknown. This specific fear didn't pop up until the 19th century.

**6.** On Friday, October 13, 1307, hundreds of the Knights Templar were arrested in France, long before Friday and 13 were considered a bad combination. Dan Brown's book <u>The Da Vinci Code</u> popularized this connection to the superstition.

**7.** Fear of Friday the 13th is called paraskevidekatriaphobia.

**8.** In 1882, Civil War vet Captain William Fowler founded The Thirteen Club to dispel the myth that 13 is a bad number. Their first meeting was held Friday, January 13, at 7:13 p.m. The group of 13 walked under a ladder, then spilled some salt without throwing it over their shoulder.

**9.** Part of the fear of thirteen comes from a belief that if thirteen people eat together, one of the diners will die. This superstition is tied to Last Supper and an old Norse myth.

**10.** In Spanish speaking countries and Greece, Tuesday the 13th is considered unlucky.

**11.** Although less people go out on Friday the 13th in English speaking countries, it's typically more safe than other Fridays as people are driving more carefully.

**12.** The earliest known reference to Friday the 13th as unlucky comes from a 1869 biography of Gioachino Rossini, who died on a Friday the 13th.

**13.** Friday the 13th will occur three times in 2015, in February, March, and November. The next time it will happen three times in one year will be 202

### City Council Minutes – February 2, 2015

Mayor Shebetka called the regular meeting of the City Council to order at 6:00 pm in Springville City Hall. Present on roll call: Brady, Hoyt, Ralston, Merritt and Sindelar at 6:10 p.m.

Public Hearing: Caraway Plat of Survey #1968, tabled.

Consent Agenda: M/b Brady, 2<sup>nd</sup>/by Merritt, to approve the consent agenda as posted. All ayes, m/c. Public Forum: Deb Vaughn thanked the Public Works Department for the good job they have done on cleaning the streets. Deb also thanked the Council for sponsoring the Open Meeting/Open Records seminar. Deb felt the information provided was very beneficial.

It was noted, 502 Broadway needs to clean their sidewalk and remove the truck and trailer that is left parked on the street for long periods of time.

Reports-Sheriff: Deputy Egli provided the service log for January 19, 2015 through February 2, 2015. There were 22 calls for service. January hours of service: 130.07. Egli reported that the parties who committed the thefts in Springville have been identified.

Public Works Report: Brandon gave the maintenance report.

Roger reported on his attendance at the Mayor: monthly mayor's meeting. Crime Stoppers is reemerging in Linn County. Each municipality is asked to donate \$500 to jump start the program. This will be discussed at a budget meeting. A hot topic of discussion was the commercial tax decrease and the impact it has on City budget.

Clerk: Bixler reported on solid waste credits that will no longer be apportioned to Linn County municipalities and how it affects the budget. The Council was given the Nov. and Dec. overtime reports.

### Old Business - Solid Waste Ordinance: tabled.

New Business-Committees: Roger reported on the Open Meetings/Open Records seminar given by Dustin Miller of Iowa League of Cities. Attorney Parmenter also remarked that it was a good workshop and everyone learned a great deal from Miller. Discussion continued on how the open meeting law applies to the City's Committees and Appointments hierarchy. M/b Brady, 2ns/b Ralston to disband council committees in light of the open meeting law as it applies to committees of the council.

256 Broadway Committee: tabled until the February 16th meeting.

Remote Read Meter Timeline: reviewed and discussed the project timeline for the remote read meter project. A debt service payment could take place as soon as June and most likely in December.

TruGreen: John Atkinson of TruGreen was present with information on the inventory of Ash Trees on city right of way or in city parks. inventory of 26 Ash Trees. Springville has an Two dead trees in Emmons Park need to come down. Total cost for treatment to save living Ash trees in Springville is \$3,860.

Terminix: Motion was made by Hoyt, second by Sindelar approving a one year agreement with Terminix for pest control at 256 Broadway. All ayes, motion carried.

### **City Council - Budget Work Session** February 09, 2015

Mayor Shebetka called the meeting of the City Council to order at 6:00 pm in Springville City Hall. Present on roll call: Merritt, Brady, Hoyt, Ralston and Sindelar. New Business: Deb Vaughn and Treva Davis were

present representing the Library Board. They reviewed the Library budget with the Council. Total budget request is \$79,109, a 6% increase.

Council then reviewed revenue and expenditure excel spreadsheets showing December 31, 2014 year to date revenues and expenditures. Discussion included, but was not limited to: changes in taxation law (multiresidential tax classification), business property tax credits, 2015-16 Capital Improvement Projects (CIP) and corresponding finance sources, utility rates, department budgets, and wages.

The consensus was for Bixler to use a stipend of \$800 per month and use a 2% increase for wages in order to continue with the budget process.

Public Works Maintenance Report: Council reviewed Todd's written maintenance report. Discussion was held on the data provided in the informational letter. Motion was made by Brady, second by Hoyt to participate in RAGBRAI 2015. All ayes, motion carried. Karen and Kim will head up the committee and attend the RAGBRAI informational meeting on March 28t

256 Broadway Committee: will move ahead with the 256 Broadway/Public Works Building Citizen's Fact Finding Committee. Roger has talked to various citizens about their interest in being on the committee. MSA: Mat Sauer was present to discuss a project timeline and explain how the engineering cost is derived for the 2<sup>nd</sup> phase (completion) of the sewer rehab project. Low to Moderate Income Surveys (LMI) are only good for 2 years so the City will need to complete another survey before a grant can be applied for. Discussion was also held on route 2 (the project

has been divided into 4 segments) that the Park Board picked as the first leg of the trail project. Cost of a bridge over the creek was considered to be cost prohibitive and other alternatives were also discussed. Funding for engineering costs incurred in order to proceed with grant writing will be included in next fiscal year's budget. ### SPRINGVILLE COMMUNITY SCHOOLS FACILITIES UPDATE

This past November, Springville CSD invited an independent group in to do a brief study of our facilities and provide feedback as well as hold community meetings to gather input from our stakeholders. These meetings were held during the months of January and February. We want to thank all of you who attended these meetings and for sharing your thoughts!During the February 16<sup>th</sup> Board Meeting, Duane Van Hemert and Sam Harding, from Iowa School Construction Planning Services (ISCPS) shared their unbiased assessment of the facilities and the various options that they had considered. Based on a variety of data that were consulted, along with their own assessment, they have made the recommendation to bring the student body into one, K-12, building by adding additional classroom space to the secondary building. To learn more about their recommendations the Board and Administration have asked Duane and Sam to share their final report and recommendations during a third community meeting. This will also be an opportunity for anyone to ask questions that they may have. Please stay tuned for further information about the date and time. The board will need to consider the recommendations based on the data given through this process and hold further discussions on how to proceed in addressing the district's facility needs.

A Good Story

Hours after Pearl Harbor was bombed on December 7, 1941, the Secret Service found themselves in a bind. President Franklin D. Roosevelt was to give his Day of Infamy speech to Congress on Tuesday, and although the trip from the White House to Capitol Hill was short, agents weren't sure how to transport him safely.

At the time, Federal Law prohibited buying any cars that cost more than \$750, so they would have to get clearance from Congress to do that, and nobody had time for that. One of the Secret Service members, however, discovered that the US Treasury had seized the bulletproof car that mobster Al Capone owned\_when he was sent to jail in 1931. They cleaned it, made sure it was running perfectly, and had it ready for the President the next day.

Al Capone's 1928 Cadillac V-8 "Al Capone" Town Sedan Became the President's Limo on December 1941.

Mechanics are said to have cleaned and checked each feature of the Caddy well into the night of December 7th, to make sure that it would run properly the next day for the Commander in Chief. And run properly it did. It had been painted black and green to look identical to Chicago's police cars at the time. To top it off, the gangster's 1928 Cadillac Town Sedan had 3,000 pounds of armor and inch-thick bulletproof windows.
