A STROLL THROUGH THE HIS

In 1838, Crow and Kelley families came to Brown Township

Eighteen decades have passed since the first two families settled in Brown Township. On April 10, 1838, John Crow, 46; his second wife, Docia, 42; and six of John's children arrived. Samuel and Jane Kelley, in their twenties with two little ones, also arrived that spring – exact date unknown.

JOHN CROW was born in Orange County, N. C. He and Mary Millis were married June 20, 1815, in Indiana (also Orange County). In 1834, they and their eight children moved to Illinois, living briefly in Chicago, Joliet, and Geneva. Mary, 42, died Jan. 9, 1836. The next year, her two oldest children, Edward and Garrison, went to Iowa. John married Docia Hill before they moved to Iowa. He was in Brown Township only three years, and was a justice of the peace. At 49, he died March 31, 1841, and was buried in Wilcox Cemetery near Viola. In 1850, Docia

was living in Jones County with a stepdaughter.

Of the Crow siblings, Wesley moved to Wisconsin; Nelson, Minnesota; and Garrison and his sister Polly (Mrs. Charles White), California. Edward, Hester, Nancy and John Crow Jr. stayed in Linn or Jones counties, Iowa. (Hester and Nancy married brothers, Julius and Truman Peet.)

SAMUEL KELLEY was born Oct. 1, 1813, probably in Champaign County, Ohio. He married Jane Gillilan about 1834 in Ohio. She was a native of Greenbrier County, W. Va. Their first child, Margaret, was born in Ohio; the second, William, in Indiana.

Eleven more children, including twin boys, were born in Iowa. (Only three of the 13 children were girls.) In 1843, Samuel served on a committee to organize the Democratic Party in Brown Township. Horace Brown and Isaac Butler were among other members.


The Kelley farm was along Big Wood Road, which ran through Viola from northeast to southwest. After about 16 years in Linn County, Samuel and Jane moved in 1854 to Cass Township, Jones County. Their two youngest, George and Liona, were born there.

The Kelleys were still in Jones County for the 1870 census. Sometime after that, Samuel (with Jane?) went to Glidden in Carroll County. At 65, Samuel died there April 30, 1879. His obituary said nine children survived him, but didn't mention Jane, although she was living.

In 1880, Jane was 65 and residing with her bachelor son Ansel in Buchanan County. The census listed her as insane, but her occupation as keeping house.

Five years later, the census found Jane and Ansel Kelley in Union Township, Crawford County. (Ansel's twin, Hansel, had died at 7.) Jane died between 1885 and 1900. Ansel Kelley was last heard of in 1900, living in Monona County.

The pioneers of Brown Township lived in log cabins similar to this one. It belonged to Barney and Betsy McShane, who came from Pennsylvania in the early 1850s. They were the great-grandparents of the late Aubrey McShane, who died at 101.

TWO CROW BROTHERS married three Lane sisters. Wesley Crow's wife was Fanny Lane. Nelson Crow married Eliza Lane, and (after a divorce) her sister Amanda. Father of the brides was Hiram Lane, son of Tamar Brown and her first husband. Hiram was a stepson of Tamar's third husband, Revolutionary War veteran Nathan Brown, and a half brother of Horace N. Brown. (And you thought *modern* families were complicated!)


Edward M. Crow, early Linn pioneer

Edward Millis Crow, eldest child of John and Mary Crow, was 21 when he came to lowa as a bachelor, nine months ahead of his father and stepmother. On July 4, 1837, he claimed Sections 13 and 14 in Brown Township, Linn County (Viola area). Edward thought he was the county's first settler; this is disputed. His brother Garrison, also single, joined him in August 1837.

Later, Edward moved to Buffalo Township, north of Brown. He reached age 78, outlived three wives (Elizabeth Bennett, Narcissa Bowman, and Sarah Green), and fathered eight sons and four daughters. Edward died July 26, 1894. His grave is in

Wilcox Cemetery near Viola.

Crow's youngest died in 1955

Orpha Belle Leaf, youngest child of pioneer Edward M. Crow, died at Springville Dec. 6, 1955. Mrs. Leaf, 84, was the widow of James H. Leaf. After he died, she lived on Fifth Avenue with her daughter Fannie (Mrs. Jay V. Patten). Mrs. Leaf is buried in the Springville Cemetery.

Besides Mrs. Patten, Mrs. Leaf was survived by three other daughers: Pearl Hall, Ethel Hart, and Irene Breckinridge.

The day the goats escaped

From Springville news in Central City News-Letter, Jan. 16, 1941: "There was considerable excitement on the south side Monday morning when the fence at the goat farm gave way and let all the goats out. One Billy . . . started for the home of a near neighbor and . . . jumped through the screened-in porch. He was given a cold reception, so he went on to the highway.

"Whether he was hoping to catch a ride out of town . . . or go on to the DX station on the corner for a visit with Earl George, we will never know. His plans were interrupted when Marshal McKee appeared on the scene and told Billy where to head in. The rest of the herd took the hint"

Postscript: A man named Boxwell was the goat owner. Does anyone remember where on the south side he lived? Please call Karen Taylor, 854-7422.

Brown monument fund is growing

The Springville Area Historical Society (SAHS) will meet May 8 at 6:30 p.m. in the SAHS building, next door to City Hall. Anyone interested in local history is welcome.

At the April 10 meeting, treasurer Jean Schmidt announced that a memorial gift has been given by the family of the late Aubrey McShane. SAHS voted to apply it to restoration of the Nathan Brown monument. The fund has now exceeded \$1,000, and SAHS is grateful to all donors.

Bev Franks said an application for a \$15,000 grant has been submitted to the Linn County Historical Preservation Commission by the Mayflower Chapter, Daughters of the American Revolution (DAR). She added that the national DAR will make a \$5,000 grant if the amount is matched by other donors.

Wes Bender, vice president and a veteran, reported he has met with Mike Vogt, curator of the Gold Star Military Museum at Camp Dodge, who has referred Wes to possible sources of funding for the restoration.

Bev has located names of two descendants of Nathan Brown. They are Annette Brown of Houston and Ralph Brown Martin of Covina, Calif., first cousins to each other. Nathan was their fourgreats grandfather. Both are descended from his daughter Harriet (1816-1869), who married Solomon Peckham.

SAHS president James Crow showed two undated photos of Civil War veterans' reunions of Company C, 24th Iowa Infantry. One photo has all 18 names. James' in-laws rented a farm once owned by Bert Gibson, son of veteran Benjamin Gibson.

Nathan Brown is our soldier

Nathan Brown is Springville's own Revolutionary War soldier, interred in the Springville Cemetery. Springville individuals, organizations, and businesses can show their pride by helping to restore his badly deteriorated monument. A fund has been established at the Exchange State Bank. 

We recommend to not over buy the garbage tags until we get details about the new solid waste collection contract.

M/B Gilbert to approve the consent agenda, 2/B Weber, all ayes, M/C.

Discussion was held on changes to Ordinance 165.19 M2 Heavy Industrial District zoning. Consideration was given to if Quarries should become a Permitted Principal Use instead of a Special Exception use for the zoning class.

M/B Gilbert to recommend the proposed changes to Ordinance 165.19 to City Council, 2/B Ware, Ayes: Weber, Ware, Gilbert, Besler, Stone; Nays: none; M/C.

Discussion was held on changes to Ordinance 165.08 Annexed Territory. Consideration was given to if existing structures and fencing should be allowed to continue when annexation occurs.

M/B Besler to recommend the proposed changes to Ordinance 165.08 to City Council, 2/B Gilbert, Ayes: Weber, Ware, Gilbert, Besler, Stone: Navs: none: M/C.

Discussion was held on request to rezone Spring Meadow Fifth Addition from R-2 Medium Density Single Family Residential zoning to R-3 Multi-Family Residential zoning. Considerable debate was held on risk that some future owner of the property may wish to build apart-

ment buildings on the property(s) and the potential impact on neighborhood character and property values.

M/B Weber to recommend the rezoning of Spring Meadow Fifth Addition from R-2 Medium Density Single Family Residential zoning to R-3 Multi-Family Residential zoning contingent on no separate dwelling on the second floor be allowed and no more than four units per building be allowed, 2/B Gilbert, : Weber, Ware, Gilbert, Besler, Stone; Nays: none; M/C.

M/B Besler, to adjourn meeting at 7:20 PM, 2/B Weber, all ayes, M/C

Next regular meeting well be held upon request or as needed.

Chairperson Stone adjourned the meeting at 7:12 PM.

SPRINGVILLE CITY COUNCIL Meeting Minutes, April 2, 2018

Mayor Shebetka called the regular meeting of the Springville City Council to order at 6:00 pm at City Hall. Present on roll call: Councilpersons: Dennis Thies, Brad Merritt, Jeff Grimley, Lyle Andersen, and Mareta Ralston. Rick Evans, Mike Brady, Treva Davis, Jean Menster, Todd Wyman, and Mark Bloom were also present.

M/B Thies to approve the consent agenda as amended, 2/B Andersen, all ayes, M/C.

Mike Brady expressed a concern about when the Council would be considering Fireworks rules within the City. Mayor Shebetka responded that it was on the Agenda schedule for April 16th meeting.

Dave Stone of Wapsi Waste gave a presentation for his proposal for waste services to the City, which included Tuesday pickup of one can of garbage and one of recycling each Tuesday for all residents for a flat \$12.75 fee per month. A discussion was had on potential length of contract with Wapsi Waste preferring a 3 year contract with annual review of costs. Wapsi Waste would not provide containers. M/B Merritt to accept the Wapsi Waste proposal as described, 2/B Thies, all ayes, M/C.

M/B Andersen to approve Resolution 21-2018 authorizing execution of an agreement for residential recyclable solid waste collection and

disposal with Wapsi Waste, 2/B Thies. Ayes: Thies, Merritt, Grimley, Andersen, Ralston; Nays: none; M/C.

M/B Thies to approve Resolution 22-2018 authorizing and approving a certain Loan Agreement, providing for the issuance of \$1,500,000 General Obligation Corporate Purpose Bonds, Series 2018, and providing for the levy of taxes to pay the same, 2/B Andersen, Ayes: Thies, Merritt, Grimley, Andersen, Ralston; Nays: none; M/C.

Rick Evans presented the Springville Tractor Puller Association's (STPA's) fence agreement to the City. The replacement of the current fence would be on the edge of the City property line. M/B Merritt to accept the STPA's fence agreement as proposed, 2/B Ralston, all

Rick Evans presented the STPA's fireworks permit for 2018 Fun Days. Evans mentioned that the current process requires he purchase fireworks then get insurance before asking council for a permit. He requested that when Council acts on Fireworks this year they consider changing the policy procedures so that a permit could be issued prior to the purchase of fireworks.

M/B Andersen to accept SDTA's fireworks permit for 2018 Fun Days, 2/B Merritt, all ayes, M/C.

Mayor Shebetka tabled discussion of annexations, as no new information was available at that time.

A discussion was held on how to keep water, sewer, yard waste, and garbage rates at a level that would ensure expenses were met moving forward. Clerk Bloom suggested that the FY19 rates be set as per the budget meetings for FY19, then an automatic percentage increase be scheduled for each year moving forward to cover inflation and growth. A discussion was held on how to best implement automatic rate increases. Clerk was direct to draft an ordinance that the council could vote on.

M/B Andersen to schedule a Public Hearing on May 21st, 2018 on an ordinance to set sewer, water, yard waste, and garbage rates, 2/B

Thies, all ayes, M/C.

M/B Ralston to accept LL Pelling's proposals for street sealing and chipping in FY18, 2/B Grimley, all ayes, M/C.

A discussion was held on yard waste use, rules, and nuisances. Clerk was directed to research all previous ordinances and resolutions on yard waste, then write an ordinance to allow Council to set the dimensions of waste, who may deposit waste, penalties for misuse. M/B Grimley to accept Hold Harmless agreement from a citizen whose mortgage is affected by the 5th Street Improvement Project, 2/B

Thies. Ayes: Thies, Merritt, Grimley, Andersen; Nays: Ralston; M/C.

Mayor Shebetka tabled discussion on purchase of a property on the north east corner of the 5th Street bridge, as no further action is required at this time.

During reports and discussion: Public Works was directed investigate costs to replace shop doors, Clerk was directed to put cat nuisances on the next agenda, investigate reports of unlicensed cars, and to place building permits and golf cart registrations in Council packets.

M/B Merritt to approve Resolution 25-2018 A resolution approving and authorizing a Loan and Disbursement Agreement and providing for the issuance and securing the payment of \$956,000 Sewer Revenue Bonds, Series 2018, 2/B Thies, Ayes: Thies, Merritt, Andersen, Ralston; Nays: none; M/C.

The Clerk was directed to discover if the new bonds being entered into by the city required an audit or an exam each year.
