

# EMMONS PARK PROJECT

The Springville Parks Board is moving forward with the trail project in our community. The next phase will be to develop Emmons Park. This project will include two eight foot ADA compliant walking trails. One phase of this project will create a

# Paralta's vanished store: memories from 1920's,'30s

Paralta, a hamlet about 1 ½ miles south of Springville, once had an old-time general store that also served as a post office. In the 1920s and 30s, the store sold everything from food and candy to gasoline (outside in barrels), hardware, and work boots.

The store was in the second building from Springville Road, on the north side of Bolton Street. Entering by the front (south) door, a customer saw mailboxes behind a glass partition on the left side. People needed to ask the postmaster-storekeeper for their mail. Beside the mailboxes were candy and tobacco, also behind glass.

Very few items in the store were self-serve; the customer asked the storekeeper for what he/she wanted. Beside the tobacco counter was an ordering counter. On it were a set of scales and a coffee grinder. Cloth-lined burlap bags of coffee beans were on the floor nearby.

Behind the counters were shelves reaching almost to the ceiling, with canned goods and other non-perishables. The store-keeper used a hooked stick about four feet long to pull items from the upper shelves, catching them as they dropped.

Bananas arrived on a full stalk containing several bunches. The stalk was in a tall wooden crate, made of thin boards tied together, and lined with heavy paper. Once, for a school picnic, a boy bought enough bananas for his entire class. The cost: 50 cents.

Neighborhood men gathered after supper to "chew the fat." In nice weather, they sat on the store's long front porch. With cold weather, they moved indoors around the heating stove. When all available chairs were taken, they sat on nail kegs and food sacks.

Farm eggs could be bartered for groceries; the storekeeper had to "candle" each egg. Eggshells are semi-translucent, and holding them near a light reveals the air space at one end. The larger the space, the older the egg. Storekeepers knew who always brought fresh eggs – and who didn't.

TUESDAY, NOV. 12, is the date of the next Springville Area Historical Society (SAHS) meeting. It will be at 6:30 p.m. in the SAHS building, beside City Hall. Thirteen persons attended the Oct. 8 meeting. A subset of the group had done a major reorganization. New window blinds were installed with the assistance of Mike Brady, husband of SAHS member Dixie Brady.

Once in the early 1930s, a young U. S. Department of Agriculture man came to Paralta to teach storekeeper Merritt Kyle how to candle eggs. Kyle, who had been candling eggs for years, was irked. He chose an egg that was almost straight from the henhouse. As Kyle had hoped, it baffled the USDA man. A very fresh egg has no visible air space!

POSTSCRIPT: Thanks to the memories of the late Aubrey McShane (1916-2018), who grew up on a farm near Paralta and recalled the store as it was from the mid-1920s to about 1935. As a small boy, he had a job: After school, he walked from his home to the Paralta tower (at the railroad's main line-branch line junction just west of Paralta). There he picked up a bag of mail that had come in on the train, and carried it to the Paralta store-post office for distribution.

The last Paralta storekeepers were Carl and Helen Skeels Eden, parents of Dorothy (Wood) and Richard. The store closed forever in summer 1953. (By K. Taylor)



No photos of the Paralta Store's interior were found, but this picture gives a general idea of its appearance. It also served as a post office and social center.

**IN DECEMBER 1941**, delegates from the different telephone lines around Whittier met and decided to place the central office switchboard in the home of Aaron K. Williams for the coming year.

THE WHITTIER COMMUNITY Building centennial celebration, held Oct. 13, drew a crowd of about 50. Those attending enjoyed looking at old scrapbooks, reminiscing, and tasty refreshments. Thanks to all who made it possible.

# TORY OF SPRINGVILLE, IOWA

# Joseph F. Mysak emigrated from Bohemia in June 1911

The S. S. Barbarossa left Bremen, Germany, June 11, 1911, carrying Josef Frank Myasaak and his sister Francie. They were natives of Bohemia – in 1911, a kingdom of the Austrian Empire. (It became part of the Czechoslovak Republic in 1918.)

The ship's manifest gave Josef's age as 21, but he was 28. His birth certificate has the date Oct. 26, 1882. After reaching New York City June 22, 1911, he became Joseph Mysak. Francie married a man name Labokreky; they lived in Milwaukee, Wis.

Joseph lived to be 77. About 49 of his years were spent in Iowa, almost 24 in Springville. Other places he lived were Amana, Anamosa, Prairieburg, and Central City. Between 1920 and 1942, he and his wife had six sons and four daughters.

Trained as a butcher in Bohemia, Joseph practiced that trade in Amana. By about 1917, when he registered for the World War I draft, he lived in rural Anamosa, working as a farm hand for Mathias Lawrence. (Joseph was not called up for the military.)

On Aug. 13, 1917, when he filed a declaration of intention to become a U. S. citizen, Joseph lived near Prairieburg in Boulder Township. The declaration stated he was not an anarchist or a polygamist, and he renounced "all allegiance and fidelity to Charles, Emperor of Austria."

Joseph and Lola Louise Scroggins of Prairieburg married March 16, 1920, at St. Joseph's Catholic Church in Prairieburg. Lola was a native of Waubeek. The couple's first child, Ray-

mond, was born at Anamosa.

When Henry was born July 4, 1921, the family lived at rural Prairieburg. That was their home about 15 years. Charles "Charlie" arrived just before midnight Feb. 1, 1923; his twin, Mary Gertrude (named after Lola's mother), was born Feb. 2.

Next came Emma, Francis, and Donald. Joseph rented farms, then bought one which he lost in the Depression. The family lived two or three years at Central City, where Everett was born. By then, Joseph was working for LaPlante-Choate in Cedar Rapids, building earth-moving equipment.

On Sept. 1, 1936, the Mysaks moved to High Street (now Avenue) in Springville, and Joseph worked in construction for Fred Nelson. Joseph and Lola's last two children, Dorothy and Joan Marie, were born in Springville. All ten of the Mysak children were born at home.

Joseph died July 20, 1960, and was interred at Mount Calvary Cemetery, Cedar Rapids. He and Lola had been married over 40 years. Lola and her second husband, James Clark, were together almost 20 years, until her death at 83 on June 12, 1984. Lola is buried beside Joseph.

Today, Everett Mysak lives with his wife Glenda in Springville, and Dorothy Mysak Loehr is a resident of Lisbon. Their eight siblings are deceased.





# **United States Census 2020**

Did you know the U.S. Census Bureau data helps determine how billions of dollars in federal funding flow into states and communities each year?

By April 1, 2020, every home will receive an invitation to participate in the 2020 Census. You will have three options for responding:

- 1. Online.
- 2. By phone.
- By mail.

\*\*The 2020 Census marks the first time you'll have the option to respond online. You can even respond on your mobile device.

If you live in the United States, you are required by law to complete the 2020 Census.

You may already notice census takers in your neighborhood. This is a normal part of preparations for the 2020 Census.

# **Avoiding Scams Online:**

The Census Bureau will never ask for:

- Your Social Security number.
- Your bank account or credit card numbers.
- Money or donations.

# Staying Safe at Home:

- Check for a valid ID badge, with their photograph, a U.S. Department of Commerce watermark, and an expiration date.
- If you still have questions about their identity, call 800 -923-8282 to speak with a local Census Bureau representative.

October 7, 2019

The pledge of allegiance was recited to begin the meeting.

The Springville City Council met in regular session in the Springville Council Chambers on October 7, 2019. Mayor Shebetka called the meeting to order at 6:00 p.m. Council members present: Brad Merritt, Lyle Andersen, Jeff Grimley, Dennis Thies and Mareta Ralston. City Staff present: Public Works Director Todd Wyman, and City Clerk/Treasurer Dee Wagaman. Guests present: Mike Brady, Kevin Hulett, Patrick Hoyt Jr., Kim Donaldson, and Chris Williams.

Thies made a motion to approve the agenda, second from Merritt. All ayes. Motion carried.

Andersen made a motion to approve the following consent agenda items: Approval of September 23, 2019 minutes, Approval of bills, and Approval of Sally's Liquor License renewal second from Merritt. All ayes. Motion carried.

Mayor Shebetka invited citizens with input to speak. There being no comments from citizens, Mayor Shebetka moved to business.

Mayor Shebetka opened the public hearing to consider amending Chapter 23 of the Springville Code of Ordinances pertaining to Park Board at 6:02 p.m. No comments in favor or against the proposed changes. Andersen made a motion to close the public hearing at 6:03 p.m., second from Thies. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Ralston. NAYS: None. Motion carried. Andersen presented first reading of Ordinance 17-2019, an Ordinance to amend Chapter 23 of the Springville Code of Ordinances, second from Grimley. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Ralston. NAYS: None.

Mayor Shebetka opened the public hearing to consider adding Chapter 53 to the Springville Code of Ordinances pertaining to Noise Ordinances at 6:05 p.m. No comments in favor or against the proposed changes. Wagaman explained the attorney opinion on enforcement. Thies made a motion to close the public hearing at 6:08 p.m., second from Merritt. RCV: AYES: Thies, Merritt, Grimley, Andersen, and Ralston.
