The SANSI Benefit will not be held .

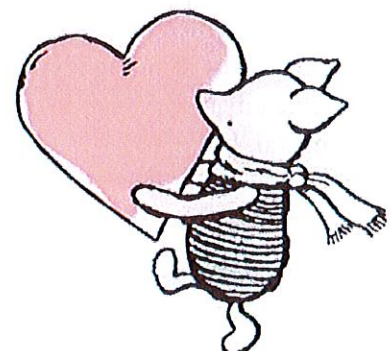

A STROLL THROUGH THE HIS

Nancy Butler Jarmon's Springville memories from the 1940s

The following article was written by the late Nancy Butler Jarmon. Titled "Springville in My Life," it was published in the 1981 Springville Centennial History.

I came upon the scene in the late 1930s, and have many fond memories of Springville as it grew and prospered. My father, Tim Butler, and his brother Hillis had the good luck to be taken from a foundling home in Cedar Rapids and raised by C. F. "Fred" Butler. I was only 5 when Grandpa Butler died (1941), but I remember sitting on his lap and his giving me some money for my birthday.

He raised the two boys and his daughter Margaret, and gave them a good start in life. I guess my dad and Hillis were quite the characters. One Halloween they rolled the big rock that marks Butler Park down and over the bank and into the creek under the front (*Broadway*) bridge. They were found out – I don't know how – and made to take it back to the place where it now sits.

My dad was also a cheerleader back in the 1920s when we had that famous basketball team. He must have been quite an acrobat, because he went the length of the floor doing cartwheels and flips.

Fred sent both of the boys to college. My dad went to Coe for a year and became a champion billiards player there. He also learned to mix colors in art class, a knowledge he later used in painting and decorating.

Hillis learned photography, which became his life profession. He settled in Illinois and went into wealthy homes taking pictures. Coming home from one of these trips, he was killed in an automobile accident. I remember going to his funeral. His wife Margaret later died of bone cancer. They had no children.

Dad met my mother, Lodima McKinstry of Anamosa, at a dance. They danced their way into marriage and all through their life together. I remember sitting on the side-

lines and watching them at the weekly dances in the Odd Fellows Hall, or at the dances they held on the blocked-off Main Street (*Broadway*).

We lived right on the downtown strip in the upstairs apartment located where Roy Fuller now has his barber shop. Below us was the restaurant run by Rennie (*Lorenna*) and Guy McKee. Just south was the little house of Bert Jenkins, a railroad man, and his wife, who had long dark hair and wore lots of beaded necklaces.

On the north was Bucky (*Loren*) Brown's harness and shoe shop on the main floor of the IOOF (*Odd Fellows*) building, and below his shop was a favorite hangout for all the men, the pool hall run by Denny Taylor. He sold the best-looking Delicious apples in town at his candy counter. I used to go down there a lot to call Daddy for supper.

They used to block off Main Street and have matches between wrestlers who came to town to challenge the local men, but I didn't get to watch my dad perform because I got the chickenpox.

On the other side of Denny Taylor's house (now the antenial Country Store) was Jordan's Hotel with a fan- / fish pool and garden. My mother took a picture of me ere in my new high-button shoes. When she left, I ded- ded to go wading – still in my new shoes!

Everyone remembers the Jordans. They ran the drug- ore and beer bar across the street. I talked endlessly with d-haired and painted Vida (*Mrs. Jordan*), and admired r yellow cat and her big green parrot who could talk. (*Ar. Jordan was Frank.*)

I went to (*John*) Alexander's butcher shop for bubble m, or I'd run into Mr. (*William "Billy"*) Bell on the reet and he'd give me a bright shiny penny. Living own- town had its advantages and I felt like I had a lot of cles. The post office was around the corner (*on Liberty venue*) and Glenn Bowdish never forgot my birthday – e even remembered it last year.

I spent many hours in the telephone office over the post fice, talking to Irma Schwab or Mabel Walton and

watching them operate the switchboard. There was Rod- dy's barber shop next to the post office, and Dr. (*G. W.*) Gearhart's office, a little brown brick-sided building west of the alley. I'll never forget Doc driving his old coupe convertible down the street.

I remember Ralph Hunte's furniture store and the mys- terious mortuary in the basement. I stood by the pot- bellied stove in the depot waiting for the Milwaukee Puddle Jumper to come through and take us to Anamosa to visit Grandma. I'd watch Mr. (*Lewis*) Miller and try to figure out his codes as he pounded away on the tele- graph key.

Nancy Butler was born June 4, 1936. Her father Charles "Tim" was the foster son of banker Charles "Fred" Butler and his wife Clara. Nancy graduated from Springville High School in 1954 and married Ronald "Ron" Jarmon Nov. 15, 1958. They had three sons: Randall, who died as a baby; Scott of Ames; and Tracy of Marion. Nancy worked at Rockwell Collins 37 years, retiring in 1991. She died May 23, 2013. Her siblings were Yvonne, who died at birth in 1935; Ken (1942-2014) and Rita Butler Fehlhafer of Springville.



In 1905, Dr. G. W. Gearhart had this office building constructed on Liberty Avenue, six years after he came to Springville. His first and middle initials stood for George Washington. The building has 670 square feet. For decades, it was covered with asphalt siding made to resemble bricks. (*Photo courtesy of City Clerk's Office*)



In October this year, the 117-year-old building got a brand new look when its present owner, Bill Campbell, had tan vinyl siding installed. Dr. Gearhart practiced medicine in Springville for 57 years, retiring in 1956. He died July 23, 1969, age 96, at the Springville home of his daughter, Mrs. Margaret Johnston (wife of Andy).

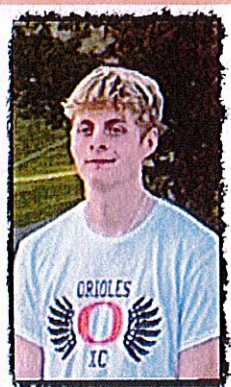

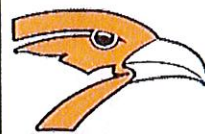

The Springville City Council met in regular session October 3, 2022.

Pledge of Allegiance was recited.
