FALL IS HERE!

The changing of weather and seasons is a beautiful time of year, some would even say it is their favorite time of year. The leaves changing colors is an amazing site, but it can also leave a mess behind (no pun intented). Just a reminder about your leaf pick up, the City of Springville does not allow you to burn your leaves or put them in the street. We don't have the equipment to pick them up. We do have a yard waste site that you are welcome to use. We appreciate your cooperation in this.



YARD WASTE SITE

The City operates a yard waste site for residents to dispose of grass clippings, shrubbery, garden waste, leaves, trees and branches. The site is located at the north end of JR Barnes Parkway. This area is to be used by SPRINGVILLE RESI-DENTS ONLY and is NOT FOR GARBAGE. You must divide your yard waste in the appropriate areas: (1) grass, leaves, garden waste, and small brush up to 1/2 inch in diameter, or (2) brush and trees. No yard waste shall be left at the site in any container, such as garbage bags, boxes, garbage cans or other receptacles. All of the by-products resulting from the use and maintenance of the yard waste site (mulch, compost and firewood) may be used at no charge by any City resident.

TRICK-OR-TREATERS

The community will be observing trick-ortreating on Monday, October 31st. Please be watchful of all the kids in costumes. Please make sure you have your porch light on so they know it is safe to come to your door.

You have the option to shut your water off at the street or to make your account inactive. We would also like an number of someone local to contact in case of an emergency.

Ground broken for new school

This is an architect's rendering of the new Springville Elementary School now under construction. The front entry will face west-southwest. Ground was broken for the one-story building September 6, with a ceremony September 14 involving all classes, preschool through 12th. Completion of the 18,000-square-foot structure is set for August 2017. The new school is being built on the site of century-old Schwab Hall, which was razed this past June.



DO YOU REMEMBER WHEN...

Margaret Paul performed in Chautauqua

Only the most senior citizens now can recall popular summertime events called Chautauquas. These shows started in the 1880s – before radio, movies, and television, and *long* before social media. They were enjoyed by thousands, peaked in the 1920s, and vanished by 1940. Most people younger than 90 know about them only secondhand – if at all.

Chautauqua performers traveled to small towns, bringing excitement with live entertainment. For decades, summer meant Chautauqua shows in big brown tents. Not only did they entertain, they also educated (enjoyably), bringing new ideas and expanded viewpoints. Chautauqua performers included musicians, lecturers, humorists, dramatists – and more.

A Springville woman, Margaret Dorcas Paul, performed in Chautauqua as a dramatic reader in the summers of 1914 and 1915. Born in 1887, she graduated from Springville High School in 1904; taught at the one-room Prairie Valley School south of Whittier, and a couple of other schools; and earned a two-year certificate from the Cornell College School of Oratory.

In 1913, Margaret entered the Leland Powers School of the Spoken Word in Boston. Powers, then 56, was a nationally recognized elocutionist. Margaret had seen him at a Chautauqua in Iowa. He and his second wife, Carol, directed the college-level school, limiting enrollment to 140 students. Margaret was honored and thrilled to be accepted.

The Powers school year ran from October to April. Living in Boston was a great experience for a farm girl who hadn't traveled outside Iowa before. Besides honing her skills, Margaret enjoyed Boston's many cultural and historic benefits. She even marched in a women's suffrage parade, six years before women got the vote in 1920. (Nothing was thrown, to her relief!)

Back in Iowa, Margaret served two years as head of the Expression (Speech) Department at Lenox College in Hopkinton. While teaching there, she was permitted to complete her B. A. degree. (She had earlier been passed over for a job at Epworth Seminary in Dubuque County, for lack of a degree.)

Margaret's next location was northern Indiana, where she taught at Whiting (two years) and Gary (25 years). Emerson High School in Gary was very progressive, with a "whole child" educational approach. After retiring in December 1944, Margaret lived in Marion, Iowa, with her sister and brother-in-law, Effie and Ernest Kennedy. For many years, she served on the Marion Library Board. Margaret Paul was 85 when she died July 19, 1972. She is buried with her parents, George and Anna Ford Paul, in Springville Cemetery.

Another Springville performer

Another Chautauqua performer from Springville was Glenn Calvert Bowdish, born in 1904 (the year Margaret Paul graduated from high school). According to his 1994 obituary, he was with the Redpath-Vawter Chautauqua circuit seven summers, but no other details are known.

Bowdish, son of John S. and Ida Calvert Bowdish, was a 1922 Springville High School graduate. His Chautauqua years possibly were 1922 through 1928. In February 1929, he married Martha Jane Chenoweth in Missouri. Appointed Springville postmaster in July 1936, he held the post 38 years – a record for this town.

Grandparents to lowa in 1843

Margaret Paul was the granddaughter of Jonathan and Dorcas Wilson Paul, who came to Iowa from Pennsylvania in 1843. Their son George (Margaret's father) was born in 1845 in a log cabin on McShane Hill, south of Springville.

George married Anna Ford in 1877. They built a home and farmed west of Springville on Burr Oaks Road. Margaret was the youngest of their four children. The farm was later home to the late Paul and Maurita Hoffman Ewart. Paul Ewart's mother was a first cousin of Margaret Paul.

Pioneer documents given to SAHS; next meeting to be October 11

The Springville Area Historical Society (SAHS) will meet Tuesday, Oct. 11, at 6:30 p.m. in the SAHS building, next door to City Hall. All who are interested in local history are invited; membership is not required.

At the Sept. 13 meeting. Shirley Pollock Parker gave SAHS five historical documents which had been in her family, pertaining to early Springville area land purchases. Her grandfather, Thomas Wilton Pollock (1859-1949), owned 440 acres of the farm that had belonged to Horace N. Brown, son of Revolutionary War veteran Nathan Brown.

One of the documents, dated June 15, 1854, is Horace Brown's certificate of purchase for 40 acres in Section 31 of Brown Township. The name of President Franklin Pierce is on it. When Horace died in 1893, he owned at least 700 acres, but not all was bought at the same time.

Two other certificates are for Section 32 purchases in 1841 and 1848 by William Stiles or Styles. He was born about 1818, possibly in Virginia. In about 1851, Stiles ran off with Horace Brown's wife, Sarah Jane, while Horace was prospecting for gold in California. There was a divorce, after which the runaways married, had seven (eight?) children, and lived in Fairfield, Iowa. Horace and his second wife, Julia A. Chapman, were married in 1853.

Still another certificate, dated Nov. 10, 1841, bears the name of George H. Robinson. He was the son-in-law of Springville pioneer Isaac Butler, having married Isaac's oldest child, Sarah, in 1831 in Indiana. George was 33 when he died in 1847, leaving Sarah a widow with four children. She later married Samuel Starry and had five more offspring.

Among other topics discussed were the effort to obtain a government marker at the cemetery for Korean War casualty Robert Newman; the upcoming Sept. 26 public meeting of the Parks Board to discuss a Springville walking trail, and the two glass display cases acquired by Bev Franks. A request by SAHS vice president Wes Bender for funds to attend the lowa Museum Association conference in October was approved by vote of members.

Others attending the Sept. 13 meeting were James Crow, president; Jean Schmidt, secretary-treasurer; Karen Taylor, historian; Doug Beard, Rick Heeren, Dave and Eleanor Kelley, Bob Parker, Pat Rose, and Kelly Schmidt.





Also in attendance was Public Works Supervisor Todd Wyman, Jennifer Wyman, Dave Raue, Treva Davis, Donna Kibler, Kurt Gillette, and guests Ryan Schlader with Linn County Conservation, Lane Lebahn with Advanced Systems, and Liz Kemp with MSA. M/B Thies, to approve the consent agenda, 2nd/B Hoyt, all ayes, M/C.

Reports-

Linn County Sheriff- Deputy Steffen, reported 26 calls for service and 138.7 hours logged.

Mayor Shebetka – along with Councilman Dennis Thies, attended the lowa League of Cities Annual Conference in Des Moines. Highlights included classes on Budgeting, TIF, Making the Most of Work Sessions, Using Debt to Fund Projects, All Things Utility, and the Use of Solar Energy. Very worthwhile event.

Guests-

Ryan Schlader with Community Outreach for Linn County Conservation was in attendance to present the need for the upcoming bond referendum on this Novembers ballot. This is a \$40,000,000 project ranging from Water Quality and Land Protection, Park Improvements, and Trails Improvements. If approved by Linn County Voters, it will cost an average of \$27.00 for an assessed home of \$140,000. Lane Lebahn with Advanced Systems presented on Laserfiche, a document management software. The key points to this particular management software is length of time used is significantly reduced for retrieving information, security of information is improved, and environmentally sound by reducing paper usage.

Liz Kemp with MSA was present to further discuss the CDBG Housing Grant Application. Twenty four applications have been received. Further explanation on the whole process was given, and discussion on the benefit of city contribution to rehab instead of admin costs. M/B Thies, for the amount of \$10,000 to be used as the City's contribution towards rehab activity for the CDBG Housing Grant, 2nd/B Hoyt, all aves, M/C. M/B Merritt, to utilize the presented Request for Proposals for the CDBG Housing Grant Administrative Services and the Technical Services, 2nd/B Thies, all ayes, M/C. Small discussion on the Sewer Rehabilitation, the RFP's have been published. Cemetery purchase discussion held for a later date. The written Maintenance Report was handed out by Todd. Kurt Gillette was in attendance to further discuss the drainage issue at his residence of 203 Broadway. Paperwork with three options from the engineer was lightly discussed, but to no conclusion. Topic died from lack of a motion. M/B Hoyt, to accept Resolution #30-2016, a resolution accepting the winning bid from Mike Coonrod of \$400 for the purchase of the BushHog mower, 2nd/B Thies, all ayes, M/C. One other bid was submitted by Andy Hoge for \$100. Discussion relaying information from meeting with Bob Tobin and Jay Vavra, city engineers. Primary topic was the school addition, and key points the engineers will discuss with the school engineer. A sprinkler system was discussed, many opinions on the need and requirements, the school has contacted the State Fire Marshall and no sprinklers are required, and so will not be installed. Also discussed was 5th street. Conclusion, with school construction, the city might want to wait till 2018 to reconstruct 5th street. In addition, during the reconstruction, possible thought to upgrading the water line size, starting at High Avenue and continuing to the bridge. The engineers write up cost analysis. Clerk was directed to do a cash flow for all projects. The clerk received an email from the Marion inspectors, all is a go for the school foundation. Also, have received the signed transfer of ownership papers from the school, Mayor to sign Quit Claim Deed and the school will own this sewer. M/B Thies, to approve the purchase of the software Laserfiche, a scanner, and the contract agreement with Advanced Systems, 2nd/B Merritt, all ayes, M/C. This technology package is for city hall. The SANSI lease agreement has been dropped. The implementation of a tax abatement program for home improvements was dropped. Discussion on the acceptance of the new county wide minimum wage standards. Deputy Clerk had surveyed local businesses and all are at or above the first tier. The council felt nothing needed done for this year, and will readdress if needed. Discussion on the need for time clocks and council receiving timesheets electronically. Council will look at the language in the employee manual for the use of the time clocks. Mixed feelings on electronically sent sheets, clerk will continue hard copy. M/B Thies to permit the city engineer and the city attorney to discover the best option for the possible reopening of Water Street, 2nd/B Ralston, Thies aye, Merritt aye, Hoyt nay, Ralston aye, M/C.
