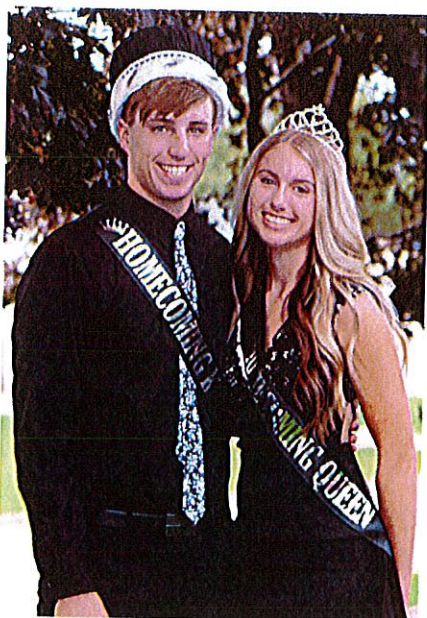
## MASK MANDATES AT SCHOOL

Springville CSD has instituted a mandatory face mask policy for all Springville buildings and activities, for anyone school-age and above, when social distancing cannot occur. This includes students, athletes, visitors, and spectators. The only exception to this mandate are those individuals who are actively participating in an activity (officials, teams playing/on sidelines). Those individuals will be governed by association or union policies. Spectators who arrive at a game without a face covering will need to purchase a disposable one at the admission table.

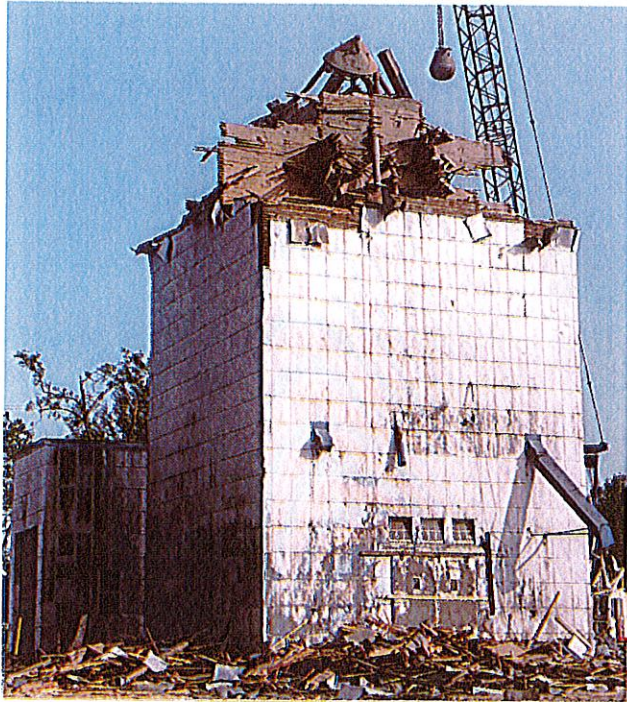

# A STROLL THROUGH THE HISTORY OF THE LINN CO-OP ELEVATOR 'wood house' is down

For the second time in six months, a building of the Linn Co-Op Elevator at Springville has been demolished, with plans for replacement. The "wood house," built in 1956, was taken down September 16-18 by Zinser Grading and Excavating.

Tracy Peyton, Springville site manager, said, "The derecho August 10 jerked the conveyor and the catwalk out, and left the building leaning to the south by about 1 to 1 ½ feet. We were already talking about replacing it because the electrical system was bad – but the storm made up our minds for us!"

The wood house was 110 feet tall and contained 16 bins with a total 50,000-bushel grain storage capacity. It will be replaced by a round steel bin, the same height, with a 140,000 bushel capacity. The exact timing for construction of the new bin has not been determined, Peyton said. It will most likely be in 2021 or 2022. Later a second new bin might be added.

In March this year, the office building (sometimes referred to as the scale house) was taken down and a new one built. It is now in use, located farther back from Broadway than its predecessor.

## Obituary

### **Bernice Bennett Carnahan almost reached age 102**

Former Springville resident Bernice "Bea" Bennett Carnahan died September 15, 2020, less than two weeks short of her 102nd birthday, at Villa Fiore Assisted Living, Prescott Valley, Ariz. A memorial service will be held in summer 2021, and burial at the Springville Cemetery.

She was born September 28, 1918, to Cleveland "Cleve" and Mabel Campbell Bennett. Her birthplace was Brookings, S. D., but she grew up in rural Springville and graduated from Springville High School in 1935.

Mrs. Carnahan was a descendant of Benona and Sarah Allen Bennett, two of the earliest settlers in Linn Township, Linn County. They arrived in the Paralta area south of Springville in 1839, coming from Michigan with their first child, Ezra. Sarah's family claimed kinship with Revolutionary War patriot Ethan Allen.

The wedding of Bea Bennett and Francis Albert "Jim" Carnahan took place October 9, 1937, in the Springville Presbyterian Church. Their marriage lasted almost 70 years, until Jim's death in August 2007. The couple

had two daughters, the late Sally Knorpp, who lived in Omaha, Neb., and Kay Keeley of Prescott, Ariz.

Well into her 90s, Mrs. Carnahan enjoyed attending Springville High School alumni banquets and talking about old times with classmate Aubrey McShane. She was the last surviving member of the class of 1935.

She was predeceased by a sister, Eula Hall, and two brothers, Clyde and Ray Bennett. Her father reached the age of 90; her mother lived to 101. Her husband was a first cousin of the late Clair "Kye" Carnahan, father of Joe and Steve Carnahan.



# ISTORY OF SPRINGVILLE, IOWA

## Could this be the old Springville school bell?

A bell that turned up recently at Marion Iron Co. has been gifted to Springville by the firm's owner, Marvin Brown. It might be the same bell that once rang from Springville's 1882 school. Most recently, it was in someone's barn.

Jake Hiner and Joy Heyer, both of Springville, hope the bell can have a role in future football games. Joe estimates its diameter at the open end is 20 inches. An "S" and "H" had been painted on it; but disappeared when Marion Iron sandblasted the bell.

The late **Bernita Wild Andersen**, a 1937 Springville High School graduate, said the school bell was rung each weekday morning by custodian **Frank Bebber**. "First bell" warned laggards to hurry. Students not in their seats when "last bell" rang were tardy.

Right after Bernita's class graduated, the 55-year-old school was razed, and construction of the present high school-middle school began. Completed in September 1938, the new school had no place for an old bell. What became of the bell is unknown.

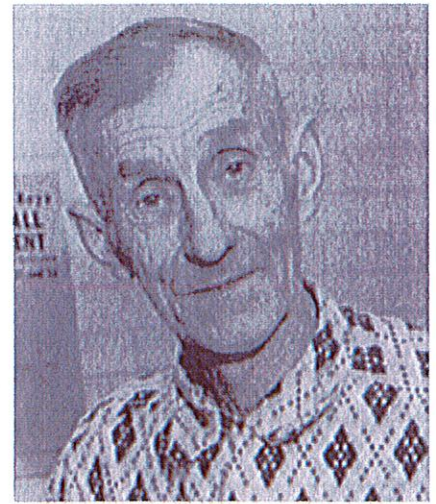
Frank Bebber retired in 1957. "That school was his life," said his granddaughter, **Nancy Bebber Akers** of Central City. In 1956, the year she graduated from Springville, the Oriole yearbook was dedicated to her grandfather.

Frank's own schooling ended in 1899; he had to go to work in a quarry at 13. In 1922, he was hired to drive a horse-drawn school bus at Springville. He became custodian in 1925.

After he retired, Frank would pick up litter and butter-nuts on the school ground, and do other useful tasks. He also raised a huge garden along Fifth Street. (His garden space is now under part of the student parking lot.) At 84, Frank Bebber died April 13, 1971.

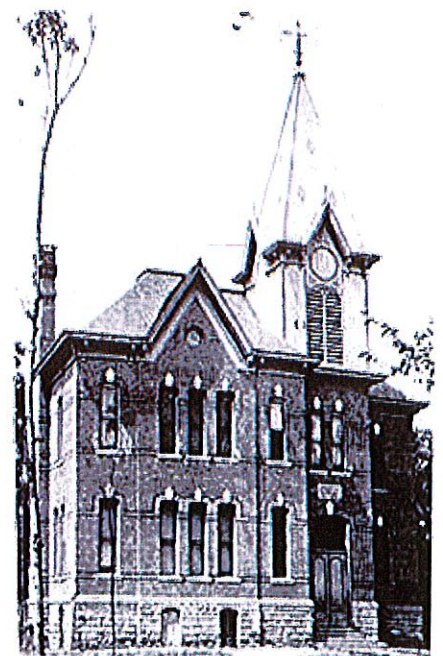

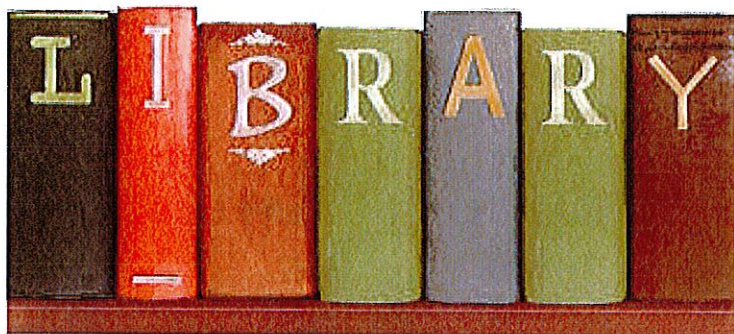

## Regular City Council Meeting—September 14, 2020

The Springville City Council met in regular session September 14, 2020. In order to help stop the spread of the COVID-19 virus, this meeting of the Springville City Council was held electronically. Chapter 21.8 of the Iowa Code does permit an electronic meeting where all members participate remotely when an in-person meeting is impossible or impractical, which is certainly true during this crisis. On March 19, 2020, Governor Reynolds issued a Proclamation of Disaster Emergency, which included a suspension of Iowa laws that would prevent the use of electronic meetings or the limitation on the number of people present at an in-person meeting site. The agenda had this message posted more than 24 hours in advance to give instructions on how others could participate in the meeting: *Due to the COVID-19 crisis, the City of Springville will be holding this City Council meeting electronically via a conference call. If you would like to participate in the meeting, please call (425)-436-6369 and enter this access code: 331423. Only City staff are allowed in City hall.*

The pledge of allegiance recited to begin the meeting.

Mayor Shebetka called the meeting to order at 6:00 p.m. Council members present: Brad Merritt, Jeff Grimley, Lyle Andersen, and Karla Blakely. City staff present: Public Works Director Todd Wyman, City Clerk Dee Wagaman, and City Attorney Mark Parmenter. Guests present: Pat and Dennis Crane.

Andersen made a motion to approve the agenda, second from Grimley. All ayes. Motion carried.

Barner entered the meeting at 6:02 p.m.

Andersen made a motion to approve the following consent agenda items: Approval of August 17, 2020 minutes and approval of bills, second from Blakely. All ayes. Motion carried.

Mayor Shebetka invited citizens with input to speak. There being no comments from citizens, Mayor Shebetka moved to business.

Hearing held on nuisance at 402 High Ave. Dennis spoke on behalf of his parents. An update on the progress that has been made and a timeline of things still needed to be done. They are debating about tearing the house down or selling and letting someone else deal with the tear down. First demo estimate came in at \$17,000. They are currently getting more bids. They are asking for an extension on the 90-day timeline. They would like to have a year to get the house cleaned out and tore down or sold. Council and Parmenter did not like to see the year extension. It was too much of a danger to be standing that long. An option was brought up to deed the property over to the City and the City would take care of the demolition and sell the lot, if there is a profit, they would forward on to the Cranes. Cranes will be back at the October 5<sup>th</sup> council meeting to discuss options.

Discussion held on Wendling annexation request. A question was brought up by council about maintaining O'Brien Lane south of Hwy 151. Will take this back to Wendling and present at September 21 meeting.

Lengthy discussion held on proposed COVID-19 policy. Council listened to employee concerns. Will make changes and bring to September 21 meeting.

Lengthy discussion held on time clock policy. Council listened to employee concerns. Will make changes and bring to September 21 meeting.

Clerk updated council on dangerous building at 301 1<sup>st</sup> Ave. Owner's insurance is just finalizing numbers. The property owner was put on notice that the building is dangerous and needs to be repaired or demolished in 30 days. There should be a resolve in a couple of weeks.

Council discussed hiring a temporary worker in the office. Andersen made a motion to approve hiring Andrea Werner for 8 weeks at a rate of \$11/hour for 20-25 hours per week, second from Barner. All ayes. Motion carried.

Andersen made a motion to approve Resolution 173-2020, a resolution to accept the bid from Kluesner construction to repair Liberty Ave. for \$9,783, second from Grimley. RCV: AYES: Barner, Merritt, Grimley, Andersen, and Blakely. NAYS: None.

## RESOLUTION 173-2020 adopted.

Discussion held on tree between 608 6<sup>th</sup> Ave & 605 7<sup>th</sup> Ave. Council does not think this is on City property. Died due to lack of motion.

Council is unclear whose responsibility the box culvert is behind 166 Circle Drive. There will be more investigating and brought back to the September 21 meeting.

Andersen made a motion to approve Resolution 174-2020, a resolution to pay off SRF Loan C0408R in the amount of \$247,450, second from Merritt. RCV: AYES: Barner, Merritt, Grimley, Andersen, and Blakely. NAYS: None. **RESOLUTION 174-2020 adopted.**

Clerk went over the SFR (Street Finance Report) for 2020. Andersen made a motion to approve Resolution 175-2020, a resolution to approve the FY2020 SFR, second from Barner. RCV: AYES: Barner, Merritt, Grimley, Andersen, and Blakely. NAYS: None. **RESOLUTION 175-2020 adopted.**

Discussion held on cemetery rates. Andersen made a motion to approve Resolution 176-2020 to set new rates for grave openings, second from Blakely. RCV: AYES: Barner, Merritt, Grimley, Andersen, and Blakely. NAYS: None. **RESOLUTION 176-2020 adopted.**

Linn County Sheriff's report presented. There were 29 calls for service between 8/17/2020-9/14/2020.

No maintenance reports.

Treasurer and Clerk report presented.

Mayor read proclamation proclaiming September 17 thru September 23 as Constitution week. Also wants council to think about Halloween and if City wants to get involved with it.

Andersen reminded everyone to fill out their reports from the Derecho so we can get a plan in place for the next disaster while it is fresh in everyone's minds.

The next regular council meeting will be September 21, 2020 at 6:00 p.m. at City Hall.

There being no further discussion, Barner moved to adjourn at 8:44 p.m., second from Andersen. All ayes. Motion carried.

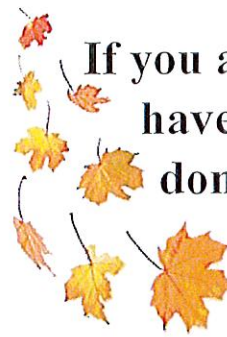
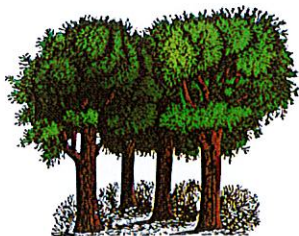
