ATTENTION: All users of Springville parks are required to remove their trash from the park and/or pavilion or gazebo. WE RECOMMEND YOU BRING TRASH BAGS TO CARRY YOUR TRASH OUT OF THE PARK.

Per City of Springville Ordinance: 55.16 ANIMALS ON PUBLIC PROPERTY. No animal shall be allowed on public property unless it is attached to a leash having sufficient strength to restrain the animal and no more than six (6) feet in length. In addition, the leash must be held by a person capable of restraining and controlling the animal.

### **CITY OF SPRINGVILLE PARK PAVILION/GAZEBO RULES**

1. No Refunds.
2. Leave shelter and surrounding areas clean. Place all trash in dumpsters provided behind City Hall.
3. Picnic tables must remain in the pavilion/gazebo.
4. Carry out what you brought in.
5. Motorized vehicles are restricted to parking areas.
6. All pets must be on a leash and all droppings must be immediately cleaned up and disposed of in a proper manner.
7. Hitting golf balls and the use of any dangerous instruments such as firearms, BB guns, and bow & arrows are strictly prohibited.
8. Fires are restricted to grills.
9. Inflatables subject to application and approval by City staff.
10. Swimming in Cox Lake is prohibited. No lifeguards.
11. For emergency purposes contact the Linn County Sheriff's Department at 319-398-3911.

## CITY OF SPRINGVILLE PARK ALCOHOL PERMIT

1. No parties open to the public.
2. Intoxicated individuals will be subject to arrest.
3. Permit must be with you at all times.
4. Alcohol must be kept within the confines of the pavilion.
5. Only beer and wine are allowed at pavilions. **No hard liquor is allowed.** Cans or cardboard containers only, **no kegs, no bottles.**
6. Permit holder accepts all responsibility for facility and participants.
7. No alcoholic beverages will be served to minors.
